Market today: Correction

- The market corrected after 4 sessions of challenging supply above the 1,160 level and failed to extend the advance.
- The correction may continue into the next trading session, but the level of the correction may not be too large and cash flow will increase to provide support as the market retreats into lower price areas.

The market entered the last trading session of the week in red and weakened early in the session. At times VN Index fell to 1,146.75. The market found support in this area and gradually recovered. However, the market failed to regain its green color and fluctuated in front of the reference level. VN index lost 7.52 points (-0.65%) and closed at 1,154.7 points. Matching liquidity increased with 1,037.9 million shares matched on HOSE.

The VN30 group gained 0.1 points (+0.01%) and closed at 1,163.66 points. In the group, there were 8 codes that rose in price such as MBB (+3.4%), ACB (+2.2%), SHB (+1.7%), CTG (+1.6%), TCB (+1.5%) ... On the contrary, there were 21 losers like GVR (-3.8%), MSN (-2%), POW (-1.7%), VHM (-1.7%), VIC (-1.5%) ...

Although the market is supported, many industry groups are in the red and the number of decliners is also high. Support came from the Banking group, which continued to see buoyant transactions and supported the general market. On the contrary, there were some industry groups that fell quite deeply, such as Real estate group, Construction group, Chemical group...

Foreign investors continued to buy net on HOSE with a value of VND17.8 billion. In particular, they bought a lot in STB (+78.1 billion), VCB (+77.7 billion), VPB (+58.6 billion), CTG (+52.5 billion), MWG (+51.8 billion) ... On the other hand, they sold heavily in VNM (-104.8 billion), BCM (-102.5 billion), DPM (-34.6 billion), HDG (-32.6 billion), KDH (-32.1 billion) ...

The market corrected after 4 sessions of difficult supply above the 1,160 points range and could not extend the increase. Liquidity increased compared to the previous session, showing that supply is still maintained and putting pressure on the market. Although the decline was at a low level thanks to the support of the banking group, the red color was quite clear. With supply still present, the correction may continue in the next trading session, but the level of correction may not be too large, and cash flow will increase to support when the market retreats to lower price areas. Therefore, investors need to observe the supportive movements of the cash flow. Currently, investors may consider waiting to buy at good price ranges for stocks that have recently established a positive accumulation base. In the short term, however, investors should still take advantage of market rallies to take profits on stocks that have risen to resistance.

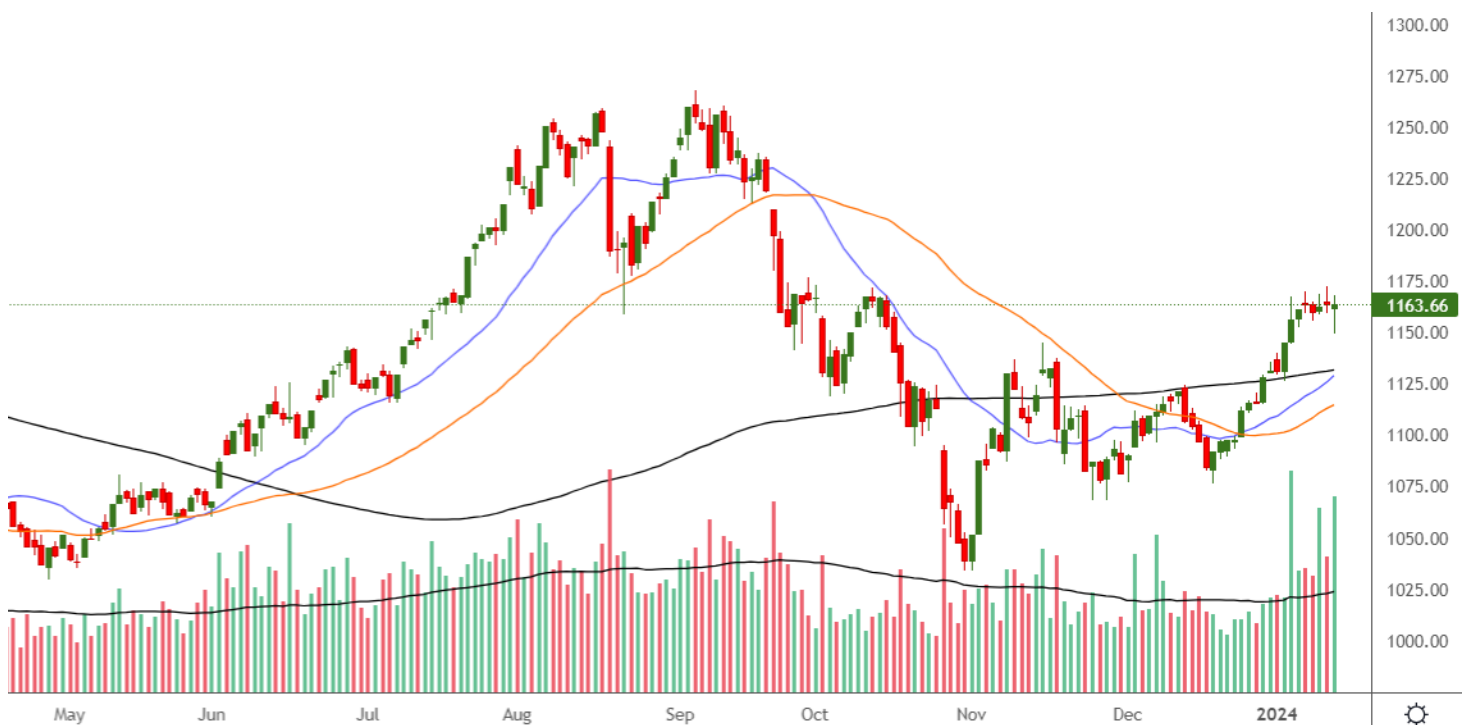
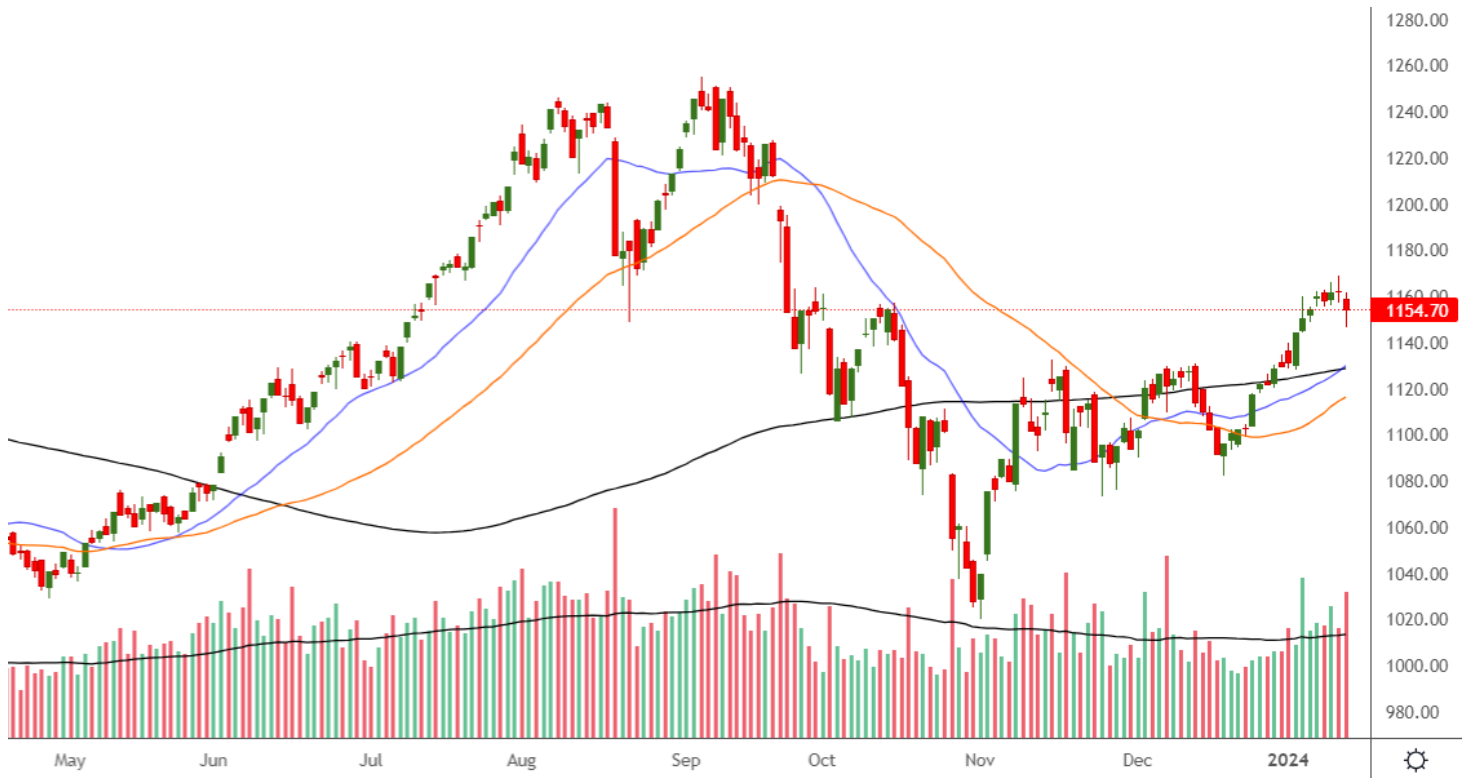
