“Banking Stocks Declines Caused Great Drop in the Market”

Market today: Banking Stocks Declines Caused Great Drop in the Market

(Hieu Nguyen – Ext: 1514)

The majority of market participant expected a correction after the arresting of members involved in economic mismanagement case in PetroVietnam (PVN), including Mr. Dinh La Thang, last week. **The VNIndex (917.45 points, -2,42%)** free fall by 23 points, but instead of Oil and gas stocks, it were banking stocks that caused the decline. CTG hit the floor while VCB, STB and BID lost by 4 - 5%. In addition, some securities companies have been cutting their margin leding, which led to the decrease of market’s cash flow in recent session.

SAB (-5%) also contributed to today’s decline. The stock fell heavily in the last two sessions, as investors were concerned about the successful of the state’s capital divestment after the case of VCG last week. This will be found out on next Monday, December 18th.

The VNIndex lost more than 5% from the peak of 970 points in December 4th, along with the decline of a series of stocks: SAB (-13%), VNM (-8%), VIC (-6%), FPT (-10%) and banks: MBB (-7%), CTG (-12%), VCB (-12%) and BID (-8%). A deep correction is understandable, as the market has been skyrocketed in a short time. If the correction continues, the index could return to around 890 – 900 points
