***Market today:* Weak session after the holiday**

Positive sentiment could not remain in the week-opening session after the National holiday. Vietnam stock indices all dropped, VN-Index could not hold the 980 level and lost 4.7 points (-0.48%), closing at 979.38. HNX-Index decreased by 0.92 points (-0.9%) and closing at 101.40. Liquidity was still at the average level on both exchanges, decliners outnumbered gainers.

20/30 losers negatively affected the VN30 group. Today VN30 lost 3.54 points (-0.4%) and closing at 888.97. Some positive gainers, such as FPT (+ 1.1%), VNM (+ 0.8%), REE (+ 0.7%) and MWG (+ 0.6%) still couldn't help VN30 index while ROS (-3.2%), HPG (-2.5%), MSN (-1.9%), STB (-1.9%), MBB (-1.3%) performed poorly and impacted negatively the index.

Industrial park stocks today dropped sharply after recent growth such as D2D (-7%), PHR (-7%), NTC (-8.8%), SZL (-6.9%), SZC (- 6.9%). Banking group was also less positive as they all dropped slightly, namely ACB (-0.5%), MBB (-1.3%), CTG (-1.2%), HDB (-1.2%), STB (-1.9%). There were still some stocks performed well: APC (+ 5.4%), HVH (+ 4%), DCL (+ 4.2%), VCR (+ 3.6%), VIB (+1.1 %).

Foreign investors saw a slight selling on HOSE of VND 12.52 bn, focusing on E1VFN30 (-VND 9.8 bn), VJC (-VND 31.3 bn), on the contrary, foreign investors had a big put-through deal on HNX on PVI (+VND 95.7 bn). They still net bought on UPCOM with VND 9.97 bn, focusing mainly on QNS (+VND 7.8 bn).

Market was no longer able to keep rising after the holiday, money was still hesitant to re-join market. There are now no outstanding groups to attract cash flow. Hence, investors need to observe more to have a suitable strategy in the near future.
