Market today: Last-minute rescue

After an unsuccessful rally, market turned cautious and fluctuated during morning session. In the afternoon, although there was a weakening signal, market was strongly supported at the end of session and returned to balance. At the end, VN-Index increased slightly by 0.32 points (+ 0.03%) and closed at 952.22 points. HNX-Index increased slightly by 0.45 points (+ 0.32%) and closed at 141.82 points. Liquidity decreased, showing no strong signal with 353.7 mn shares matched on HOSE.

VN30-Index shared the same movement with VN-Index with an increase of 0.02%. There were 7 gainers and 13 losers. Outstanding stocks among the group were MWG with a gain of 1.9%, GAS (+ 1.4%) and HDB (+ 1.2%) with an increase of over 1%. On the other side, there were losers with low drop. Notable losers were PNJ (-1.5%), followed by TCH (-1.3%), SSI (-1.1%), VHM (-1%), POW (-1%) ...

Although being not too active, Small and medium stocks continued to outperform market. Notably, there were HTN (+ 7%), NKG (+ 7%), APH (+ 6.9%), PET (+ 6.9%), TLH (+ 6.9%) ... On the downside side, the most negative was still TLD (-6.9%), followed by DGW (-3.7%), PDR (-2.8%), DCM (-2.4%), KBC (-2.4%) ...

Foreign investors continued their 4th consecutive net sell session on HOSE, with value of VND 593.7 bn. The largest net sold stock was still MSN (-127.9), followed by HPG (-105.6), VNM (-80.6), MBB (-63), CTG (-49.5) ... On the net bought side, there were HSG (+30.1), VRE (+29.3), PHR (+18.4), VJC (+18.2), IMP (+8.9) ...

Although there was weakening signal in the afternoon, VN-Index was still supported and slightly recovered at the end of the session. This shows that negative signal in last session has not been confirmed and market may gain again. However, supportive signals temporarily only appear at low level. Therefore, investors should still observe next session to evaluate market.

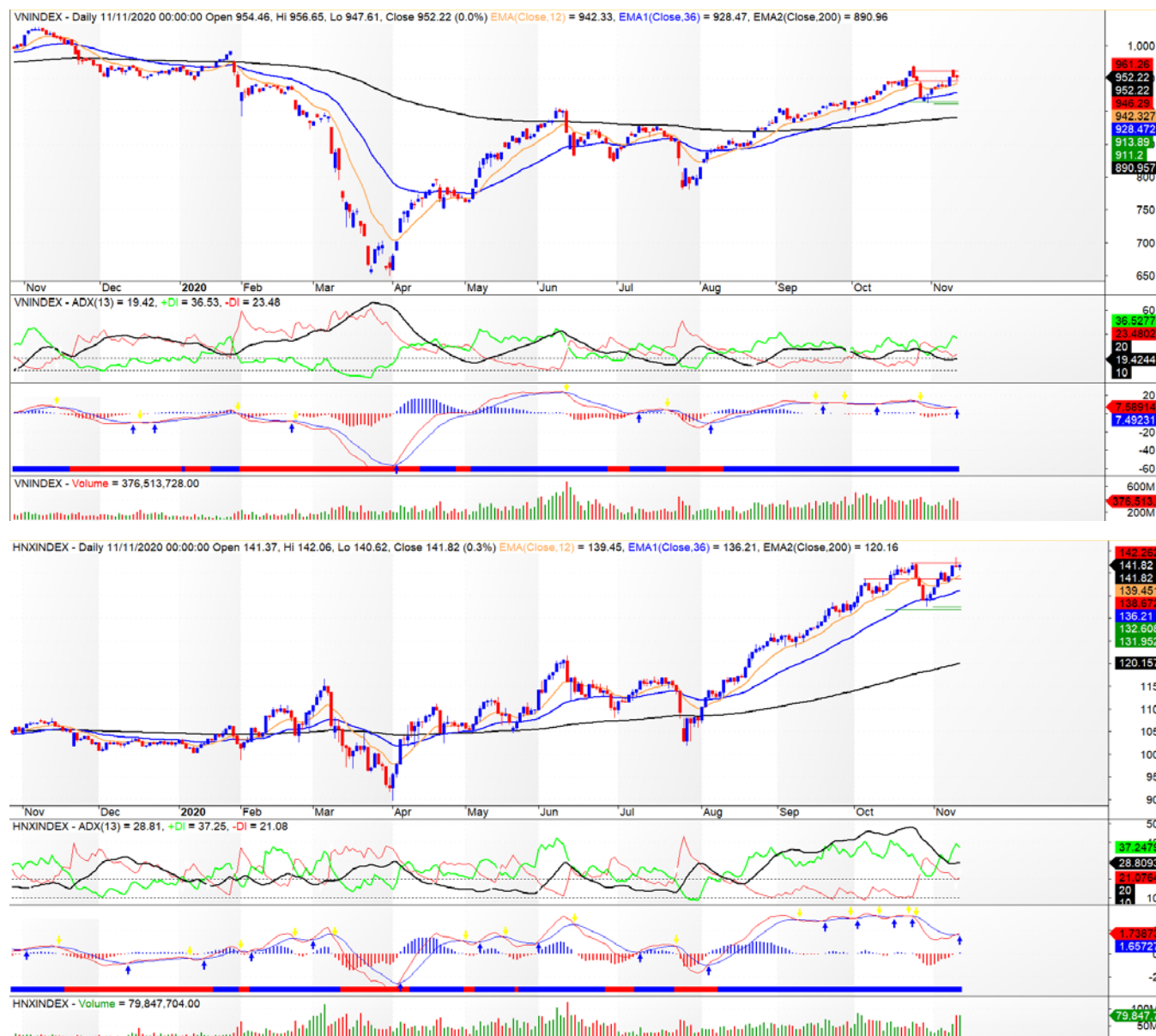

After unsuccessfully broke old peaks and corrected slightly, the market's main indexes show that the correction is about to complete and continue with the main trend. The market will be still shaking in the next sessions but the level of risk is almost gradually improving. Investors should not rush to narrow the portfolio, or waiting for the balance signals of the market to have a reasonable strategy.
