Market today: Increase in doubt

Dynamics of VNIndex came from MSN and VNM, again. MSN went ceiling in two consecutive after the company announce its share repurchase plan, while VNM continued to rise after its price being adjusted for dividend payment. These two stocks, along with GAS and VCB, pull up more than 6 points, but after the ATC afternoon, VN-Index only slight increase 0.25% to 662.28 points. Meanwhile, HN index fell 0.73% to 83.1 points due to the impact of PVS, VCG, VCS. Go into each stock, the duo HAG-HNG went ceiling again, and TTF received demand from bottom fishes after long streak of illiquidity. Specifically, there are nearly 600,000 shares of TTF being traded today, not to mention 150,000 shares from put-through deal of foreign investors.

Summing up this week, foreigners net sold an average of VND200 billion per day on the HSX. Their move is quite understandable as they bought constantly when the market fell from 681 to 620 points. Tickers being sold most were HPG, HSG, HBC, VNM, MSN, and VIC. The reason is quite diverse, from profit taking (HPG, HSG, VNM), to holdings reduction (HBC), or concerns about the internal factors of the enterprise (VIC, MSN).

VNIndex did not see any significant changes in this week. **If it wasn't for some large cap stocks, VNIndex would go down.** Therefore, Although the index went higher, not many investors could earn profit. Investors are recommended to be more cautious when markets are biased like this week. Choosing stocks with good fundamental factors, low P/E (such as shares of clinker and concrete producers, which will be benefit by growing construction activities).
