Market today: Rescue

With the cautious sentiment from Covid's complicated developments, market volatiled at the beginning of session. However, money flow still actively supported and market gradually stabilized. At the end, VN-Index increased slightly by 2.81 points (+ 0.23%) and closed at 1242.2 points. HNX-Index still fell 4.04 points (-1.43%) and closed at 277.71 points. Liquidity increased with 712.6 mn shares matched on HOSE.

VN30-Index has recovered faster than others with an increase of 1.2% at the end of session. Stocks had a positive impact on VN30 was Banking group such as TCB (+ 5.9%), CTG (+ 5.4%), VPB (+ 1.7%), MBB (+ 3%) and HPG (+ 2.9%). On the other side, there were 15 losers, in which VNM continued to drop 2%, followed by MSN (-2.1%), PNJ (-2.9%), MWG (-1,1%), VCB (-0.9%) ...

In general, Midcap and penny experienced a poor session with lots of losers. However, there was a divergence with notable gainers such as BTP (+ 7%), DCL (+ 7%), GIL (+ 6.9%), DGC. (+ 6.9%), SHI (+6.8%) ...

Foreigners continued to be net sellers on HOSE, with value of VND 637.6 bn. Noticeable name was HPG (-356.7 bn), followed by VPB (-189.3 bn), KBC (-56.1 bn), VRE (-53 bn), KDH (-49.9 bn) .. On the net buy side, outstanding stock was STB (+92.4), followed by NVL (+74.6), MSN (+26.8), HSG (+17.8), MBB (+17.4) ...

VN-Index was rescued by negative information, showing that money flow is still actively supported market and it continues to record the 4th recovery session in a row. However, market is still in the process of testing supply - demand with a remarkable resistance zone of 1250 points. In addition, there was divergence in market. Even though market rallies, there are still some potential risks. Therefore, investors should observe market's movement at 1250 point area to reevaluate market state. Moreover, stock picking is not easy at the moment; therefore, we recommend investors should keep stock proportion at a reasonable level and risk balance.

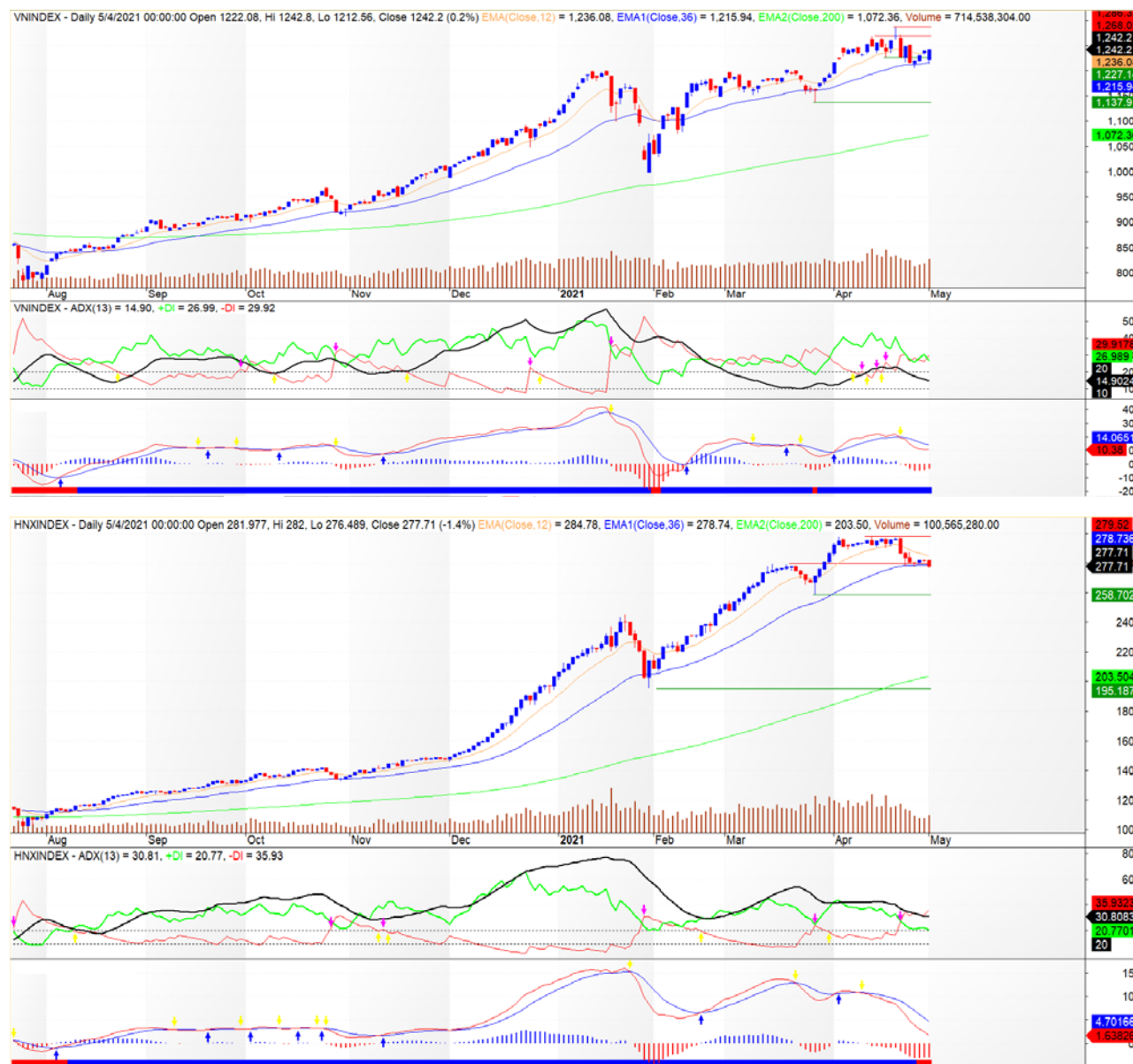
