***Market today: Back and forth***

Indices witnessed a slight volatility session. VN-Index increased slightly by 0.97 points (0.1%), closing at 975.31 while HNX-Index also increased by 0.03 points (0.03%), ending the day at 102.82. Liquidity decreased slightly on both exchanges. Gainers were about to that of losers.

Large caps were generally more positive than the overall market. While VN30-Index gained by 0.41%, VNMID-Index and VNSML-Index declined by 0.14% and 0.19%, respectively. Some significant gainers on VN30 were DPM (+ 2.5%), FPT (+ 2.3%), HPG (+ 2.2%), MBB (+ 2.1%), VJC (+ 2.1%) and BID (+ 1.9%). Only CTD (-3.1%), EIB (-2%) and VCB (-1%) performed poorly today.

Industrial Real Estate group outperformed the overall market, recording many gainers such as SNZ (+ 8.4%), SIP (+ 8.2%), KBC (+ 3.9%), NTC (+ 1.7%), ITA (+ 1.4%). In addition, some Real estate stocks also gained impressively: HAR (+ 6.9%), VCR (+ 5.8%), HDC (+ 5.6%), L14 (+4.2 %), IJC (+ 2.5%), ITC (+ 2.1%).

Seaport, Logistics, Shipping Group mostly cooled down and the uptrend could not last long as many investors expected.

Foreign investors remained to net sell on HOSE but with very small value, only about VND 18 bn, focusing on E1VFN30 (-VND 30 bn), SGN (-VND 12.8 bn), VCB (-VND 11.5 bn), PHR (-VND 9.3 bn).

*Indices stopped after a short recovery. Market fell into a balanced situation when both buyers and sellers lacked motivation. Investors should maintain both cash and stocks in the portfolio for this period when market's overall trend is not really clear.*

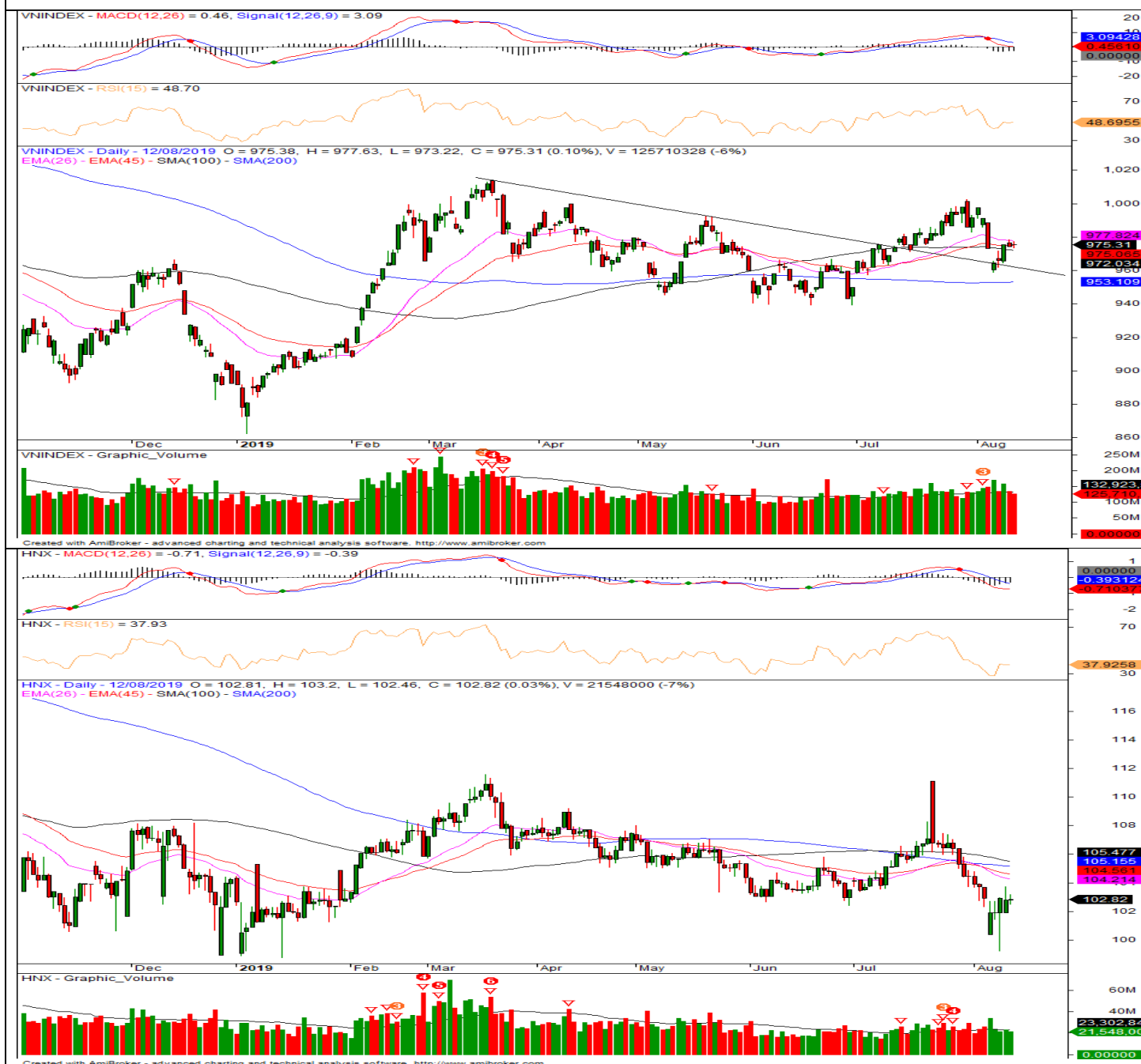
