Market today: Another strong drop

There are no bright expectations and the VN stock market deep in the red. HOSE dropped -17.63 points (-1.36%) and closed at 1279.91. In contrary, HNX increased slightly +0.14 points (+0.0%) and closed at 296.84. Upcom followed HOSE with a decrease of -0.8 points (-0.94%) and closed at 84.56.

VN30 index had another strong drop during the week with -30.57 points (-2.12%) and closed at 1410.3. Some stocks that caused the most negative impact on the VN30 index were TCB (-5.4%), TPB (-5.2%), MWG (-4.9%), STB (-4.5%)... However, there still were some gainers such as VRE (+1.4%), KDH (+1.4%), MSN (+1.0%), VNM (+0.7%).

Although the market is having difficult days, on HOSE, many names went upstream with positive status such as NHA (+6.8%), FLC (+6.3%), VCG (+6.2%), PSH (+5.5%)... On HNX, with a slight gain, there were several advancers including ART (+8.1%), NSH (+5.1%), NDN (+4.2%) ...

Foreign investors increased their net buying when the market dropped sharply with a value of VND +326 bn. It was the largest net buying value on HOSE with VND +326.54 bn and concentrated strongly on HPG (+157 bn), VHM (+145 bn), SSI (+98 bn), STB (+42.3 bn)... On HNX, there was a slight net selling of VND -1.32 bn and focused on SHB (-9.1 bn), VND (-3.4 bn), BVS (-2.0 bn)... Upcom witnessed a slight net selling with more than VND 28 mn, notably VEA (-5.3 bn), SBS (-1.18 bn), VTP (-1.12 bn) ...

There is no bright outlook to revive the stock market during this time, and at the same time, selling pressure is still maintained, making the market unable to recover after the recent sharp decline session. However, with the selling force still not breaking the positive support areas of the market, it will be easy for the market to reverse unpredictably in the future. Investors should enter the market with their reasonable cash ratio and buy stocks that are showing good signals as well as creating a stable foundation, this is a move to detect at the support zone. Hence, investors need to be careful in their movements.
