Market today: Buck the global trend

In contrast to the global trend, the VN stock market dropped sharply in the first session of the week. HOSE dropped -50.84 points (-3.77%) and closed at 1296.3 points. HNX also declined -13.75 points (-4.48%) and closed at 292.98. Upcom was no better when it decreased -3.19 points (-3.66%) and closed at 83.89.

Strong losers dominated the VN30 which lost -51.33 points (-3.43%) and closed at 1443.1. Some notable losers today were VPB (-7.0%), CTG (-6.9%), SBT (-6.9%), BID (-6.5%)... There were still several outstandings such as MSN (+2.6%), NVL (+1.5%), VJC (+0.9%), MWG (+0.1%)...

Although the stock market crashed sharply, there were still many upstream stocks. On HOSE, there were some gainers including SJS (+5.6%), FRT (+3.6%), PVD (+2.7%)... Likewise on HNX, few stocks reversed the trend today, notably PVS (+3.8%), HDA (+8.4%), SVN (+7.9%)...

Contrary to the market, foreign investors saw a strong net buying today with a value of VND +1423 bn. On HOSE, the net buying value of foreign investors was VND +1398.17 bn and focused on STB (+333 bn), SSI (+202.7 bn), HPG (+179.6 bn), KDH (+75.6 bn) ... HNX was also experienced net buying of VND +25.35 bn and concentrated on some prominent names such as BSI (+15.8 bn), BVS (+6.8 bn), MBS (+4.8 bn)... However, Upcom was a slight net seller with a value of VND -358 mn and focused on VEA (-15 bn).

The sudden sharp drop which dragged the stock market indexes to the lowest level in the last 2 months. The HOSE index have all approached the strong support zone as well as showing signs of increasing volume. It shows that the cash flow is flowing into the quite bustling market. Although the market has reached the support zone, many stocks have not yet recovered strongly, so investors should gradually disburse at a safe rate to explore this area with Bluchips falling deeply.

Technical Analyst Recommendations

The VN-Index continued to move in a negative direction, but it got some support from the 1,270 points zone. The support from the cash flow seemed to be stronger toward the end of the trading session, signaling a possible technical recovery to get back around 1,330 points. The market might recover a little bit, but the risk is still high. As a result, investors should be cautious and take advantage of the recovery phase to restructure the portfolio to reduce the risks.
