Market today: Stabilized

With a signal of retreat in the previous session, the market opened in the red and sometimes fell below 1,480 points of the VN-Index. However, the market has gradually stabilized and returned to exploration around the reference area. In the end, VN-Index dropped 0.03 points (-0.03%) and closed at 1,496.03 points. Liquidity dropped sharply compared to the previous session, with 734.1 million shares matched on HOSE.

VN30 is also supported and in exploratory status. Prominent names in this group are POW (+4.7%), STB (+2%), VNM (+1.9%), VCB (+1.8%), VRE (+1.8%) ... On the other side, there were 12 draggers such as NVL (-1.8%), TCB (-1.5%), VPB (-1.1%), MWG (-1.1%), HPG (-1%) ...

In general, the number of stocks falling in price is still quite large, and there is a significant divergence. After 3 vigorous decline sessions, the real estate group strongly regained, but there was a strong divergence and overall still slightly decreased.

Foreign investors turned to be net buyers on HOSE with a value of VND 770.5 billion. The highlight tickers were FUEFVND (+120.7), STB (+118.1), VNM (+81.3), VCB (+67.5), HPG (+57.5). ... On the net selling side, they focused the most on VND (-33.8), VCI (-22.8), VPB (-17.9), GMD (-17.1), VRE (-16.1) ...

VN-Index continued to be supported and returned to the state of exploration. In general, the market is still cautious about the impact of the recent drop. Still, temporarily the selling pressure has cooled down, reflected in the fall in liquidity compared to previous sessions. The market will likely have a recovery to retest the 1,500 - 1,510 point range for the VN-Index and the 1,530 - 1,540 point range for the VN30-Index. Currently, the divergence factor is still taking place quite strongly in the market. Therefore, investors can expect a resurgence, but for the time being, they should still be cautious about the market's risk factors and instability and continue to monitor and re-evaluate the market's status.

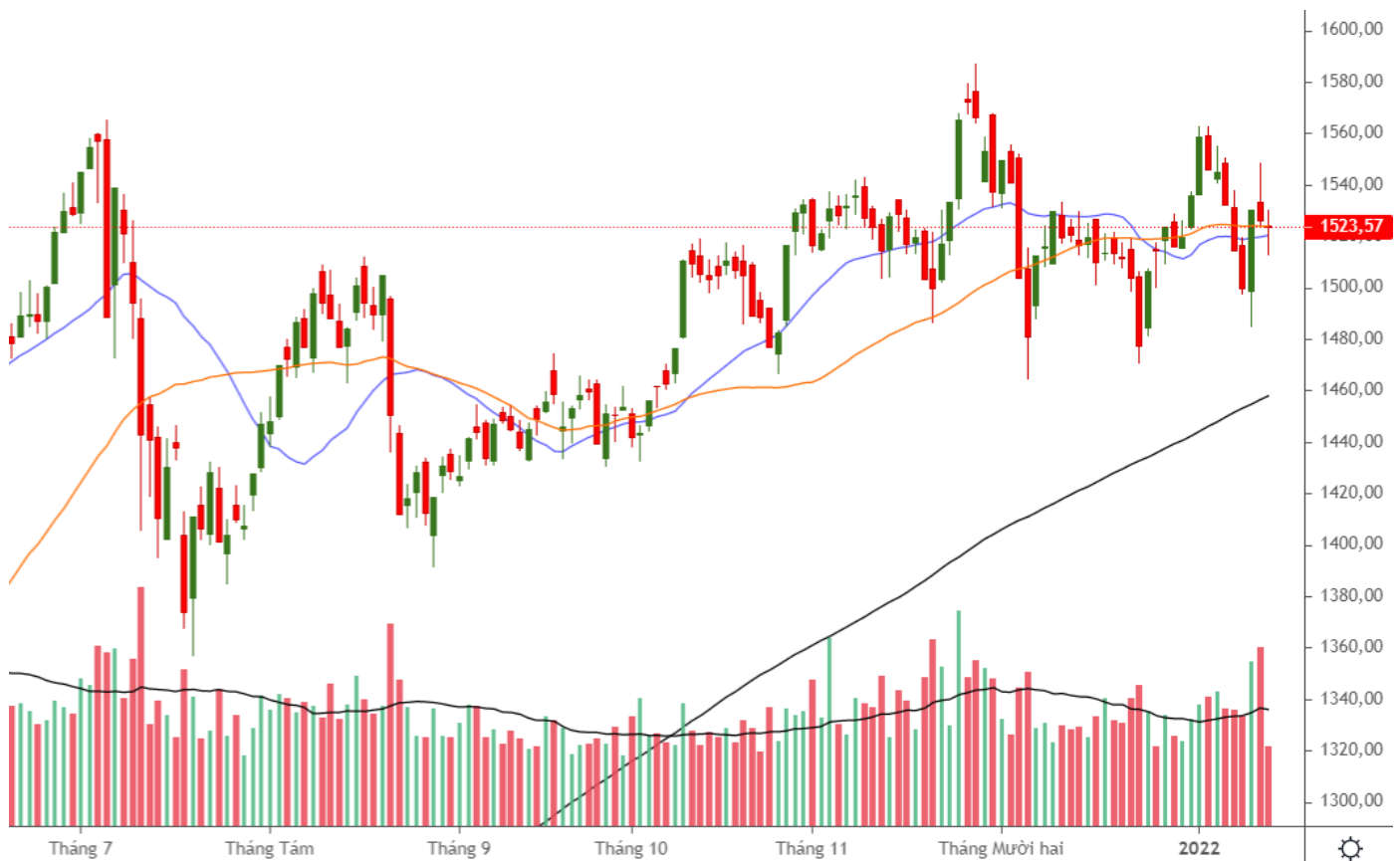
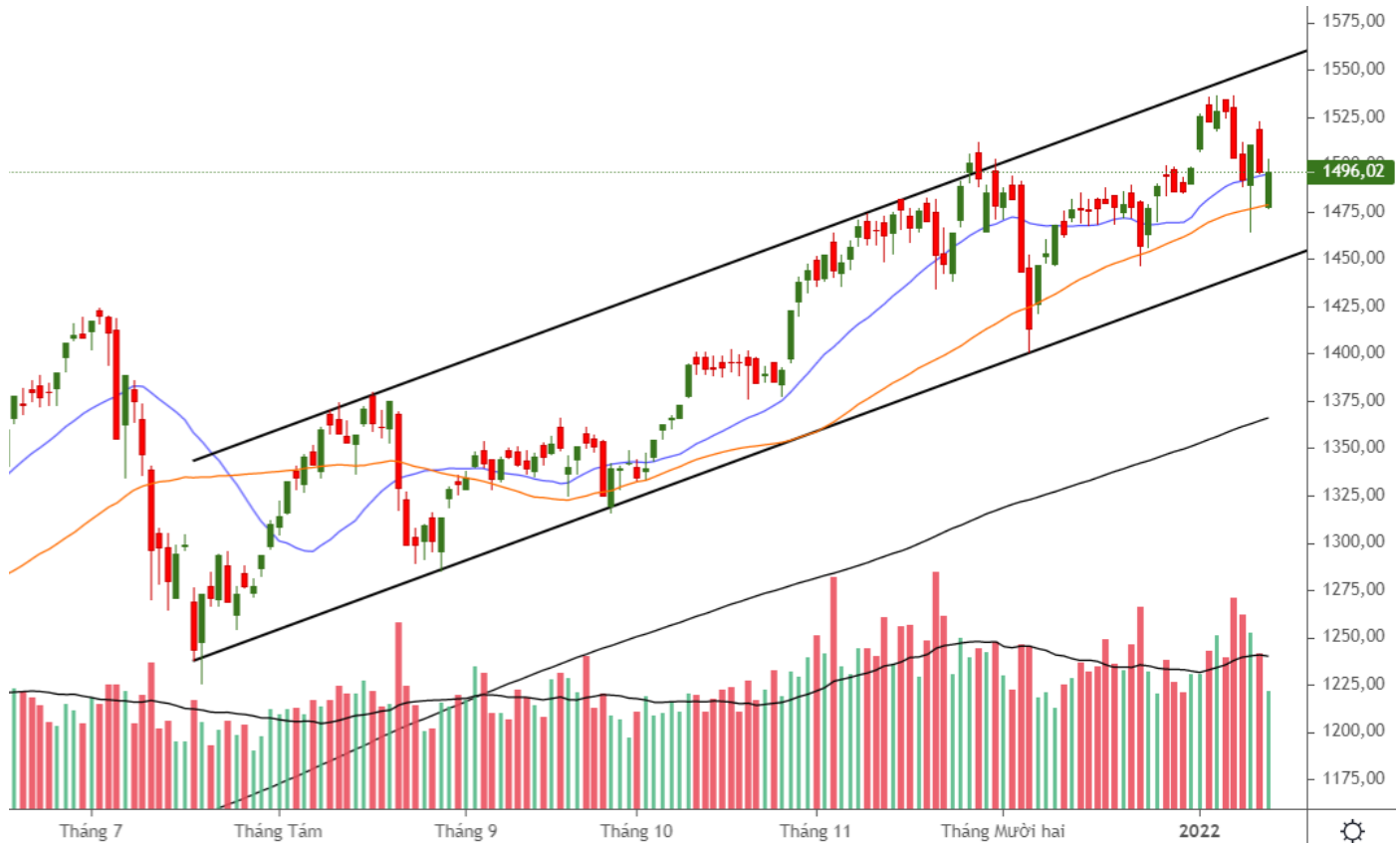

Technical Analyst Recommendations

The VN-Index got support from at the 1,480 points zone and got back to testing when the selling pressure reduced. It is expected that the VN-Index will have a recovery to test the 1,500 - 1,510 points zone. As a result, investors can expect a minor recovery of the market but still need to keep an eye on the potential risks of the market.
