Market today: Keep balance

After a failed gaining session and strong disputes, the market temporarily fell into a state of exploration. The market moves, in general, only fluctuated slightly around the reference level. In the end, VN-Index increased gently by 4.04 points (+0.28%) and closed at 1,448.34 points. Liquidity plunged, with 890.4 mn shares matched on HOSE.

VN30-Index also probed around the reference level but finished at the down zone and decreased slightly by 0.16%. Notably, SSI gained 3.1%, followed by BID (+2.2%), GVR (+1.7%), MSN (+1.6%), HPG (+1.3%) ... Conversely, there were 19 losers such as GAS (-2.4%), STB (-1.6%), CTG (-1.2%), NVL (-1.1%), VPB (-1%) ...

Pennies and midcaps gently recovered after a strong selling session but continued to have strongly diverged. Prominently, some stocks that hit the ceiling contained ACL (+7%), BSI (+7%), ANV (+6.9%), CTS (+6.9%), HBC (+6.9%) ...

Foreign investors turned to a slight net selling on HOSE, with a value of VND 74.6 bn. Most focused on PAN (-458.7 bn), SSI (-192.8 bn), GEX (-60.4 bn), HSG (-54.5 bn), VRE (-45.4 bn) ... The net buying side had some outstanding names were CTG (+68.2 bn), VHM (+61.7 bn), FUEVFNND (+53.9 bn), HCM (+50.7 bn), VCB (+46.4 bn) ...

VN-Index recovered slightly after taking profit with record liquidity. Liquidity dropped compared to previous sessions but above 50 session average, showing that profit-taking pressure is cooling down and cash flow is still supporting the market. There was a short-term previous session's profit-taking action with the current signal, and the cash flow is circulating among stock groups. These factors will shore VN-Index up to challenge the range of 1,450 – 1,460 points and be able to breakthrough. Therefore, investors can still hold the strategic portfolio and expect the market's uptrend. However, it is necessary to have a reasonable portfolio structure, boost profit taking for good price stocks. Investors who are under pressure to preserve results should wait for capturing more potent opportunities.

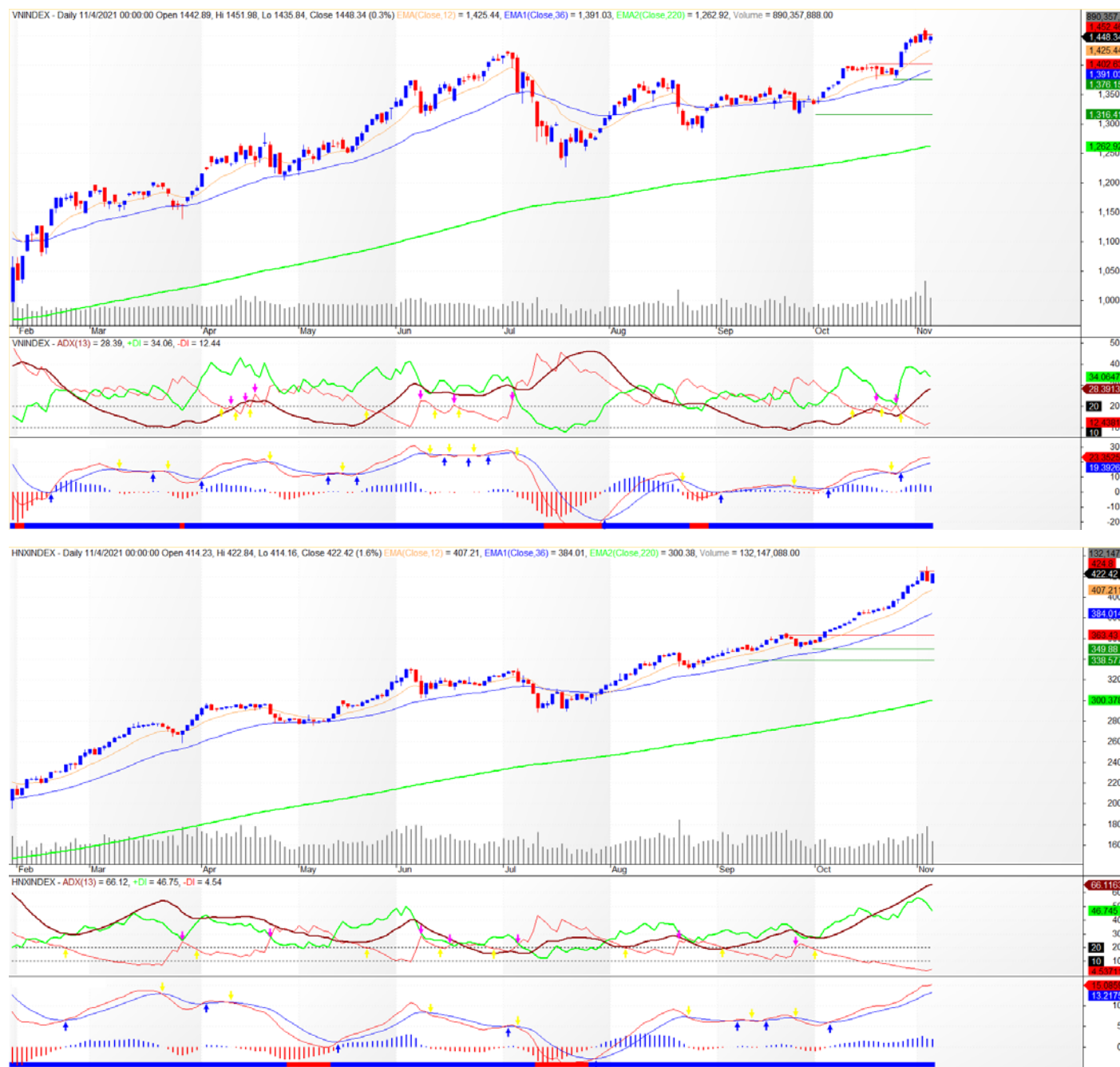
