Market today: Downtrend Remains

The market started well when it rose more than 7 points and reached 922 points. However, the support from the large caps was not strong enough. Banking stocks has not shown any improvement.

Market movements gradually turned negative as selling pressure increased. The VN-Index fell to the 900 supporting level. At the close, stocks declined in large scale. VN-Index down by 1.7% and HNX-Index down by 3.6%. VN30 Index dropped 1.9% while VNMID-Index decreased 2.32% and VNSML-Index decreased 1.4%. Liquidity on the HOSE is low, around VND 3,000 Bn.

On the HOSE, foreign investors were net sellers for a second consecutive day with a value of VND 232 bn. HDB, VCB and DHG were the stocks with the highest net-buying value. In contrast, VHM, VIC and MSN were the top net-selling stocks. On the HNX, foreigners returned to net buying with a value of VND 16.8 bn.

The market continuing to decline with low liquidity is a negative signal at this time. It is not a good idea to open positions. Any potential rebound could be a chance to reduce stock exposure.
