***Market today:* Risk of correction becomes more obvious**

(Son Tran – Ext: 1527)

Today’s market started the session by dropping slightly before strong cash inflows came and pushed the VNIndex into positive territory. However, the 1,130 point level still seems to be a tough mid-term resistance as strong selling pressure appeared and pulled VNIndex back to the negative territory before closing today’s session at 1,116 points (-0.51% for the day).

Banking stocks lost their momentum and finished down. Oil stocks were not better, not helped by the fact that WTI prices lost almost 2% overnight to USD 61.64/ barrel. Today’s best sector was steel, namely: HPG (+1.1%), HSG (+2.5%), NKG (+3%).

So far, Vietnam stock market held well despite the negative news from global stock market. However, risk of correction is becoming more obvious, therefore, we recommend that investors maintain a high proportion of cash and keep monitoring the market’s movement in the upcoming sessions.

Macro update:

February’s CPI increased 0.49% compared to the last month, which was significantly higher than the increase of 0.23% in the same period last year. CPI being high can have negative impact on consumer’s behavior and strengthen household savings. However, it is not that much of a worry since the effect of the increase in transportation cost and fuel price was already expected in the last months of 2017.
