Market today: Through the storm

Vietnam’s stock market returned to its orbit and most of the exchanges outperformed. HOSE gained 9.81 points (+0.78%) and closed at 1262.49. HNX also added 0.61 points (+0.21%) to end at 295.25. By contrast, Upcom lost 0.25 points (-0.31%) and closed at 79.81.

VN30 index flew high with 23.12 points (+1.68%) and closed at 1401.71. Many stocks in VN30 basket helped its index increased strongly such as FPT (+4.4%), STB (+4.4%), HPG (+4.3%) and MBB (+3.6%). Besides, there were some losers, namely VJC (-2.7%), POW (-2.5%), VRE (-2.2%), TCH (-1.6%).

Besides Bluechips today HOSE witnessed many strong gainers like FIT (+7.0%), ADS (+6.7%), HDC (+6.9%), DCL (+6.9%). The most notable stocks on HNX were LDP (+9.6%), HUT (+8.6%), DDG (+5.4%). Despite the slight drop, Upcom still saw many positive names such as HSV (+14.6%), LPT (+14.4%), SRB (+10.7%).

Foreign investors reduced their selling pressure but the net selling value remained at VND -254 bn. They only net sold VND -240.9 bn on HOSE, focusing on VNM (-97 bn), VPB (-87 bn), NVL (-59.9 bn), PLX (-45.6 bn). HNX also saw a net selling value of VND -13.59 bn and mainly in SHB (-26.8 bn), VND (-10 bn), IDJ (-1.6 bn). By contrast, Upcom witnessed a slight net buying value of VND +2.53 bn. VTP (+2.3 bn) and MCH (+1.1 bn) were the top buyers on Upcom.

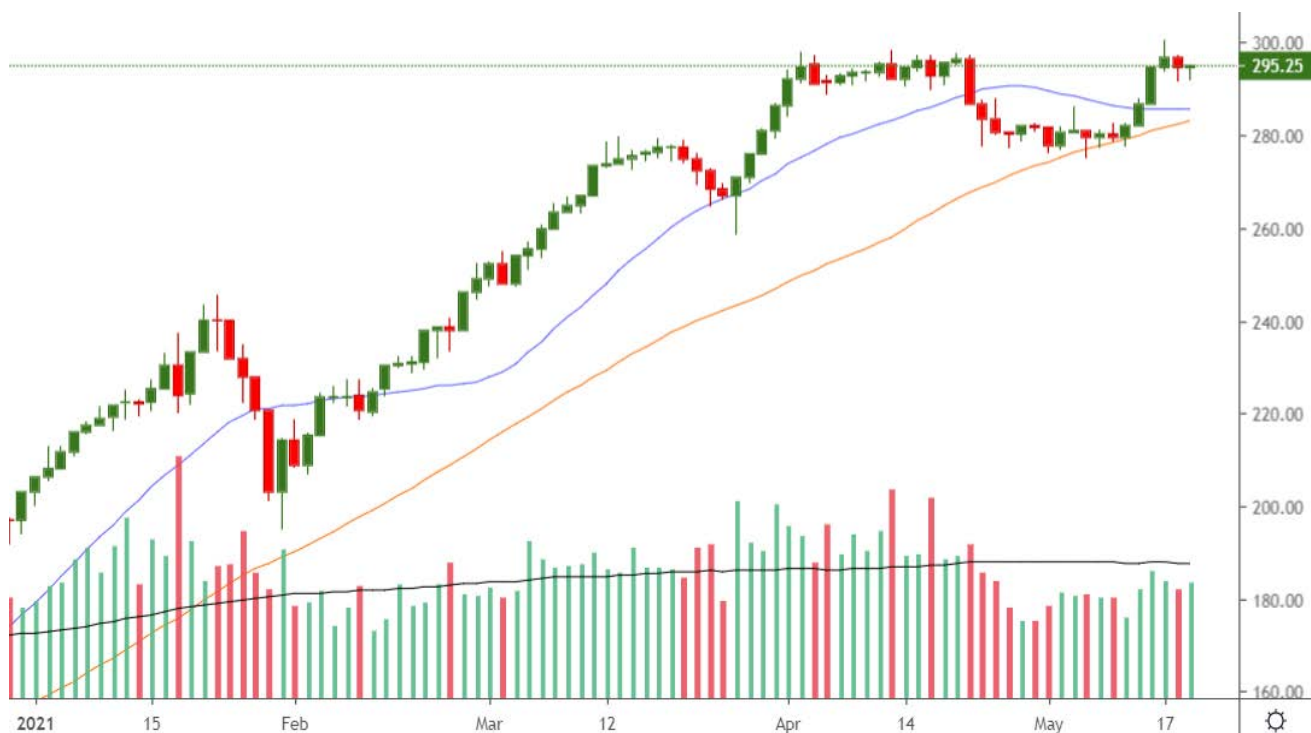

It is expected that the market will try to break the resistance zone of 1275 points in the near future.
