Market today: Low liquidity remains the biggest concern

The VN-Index failed to break the 1,070 resistance level three times, and ended up at 1,060 (-0.17%). Market breadth was relatively negative with 114 gainers and 163 decliners. Liquidity remains weak, only VND 3,750 Bn. This shows the lack of confidence in the market at present.

Noticeable block trading between foreign investors includes VND 482 Bn of SSI and VND 131 Bn of VPB. Foreigners continued to be net sellers, however. Total amount of net selling was less than yesterday at VND 175 Bn.

Low liquidity remains our biggest concern. We are still waiting for a higher volume in the market to confirm a change in market sentiment.
