Market today: The party is about to end!

After days of gaining, stock market had its first correction session. On Hose, VNindex fell -7,49 pts (-0,6%) and closed at 1234,89. On HNX, HNX index increased slightly by 0,91 pts (+ 0,31%), to close at 293,75. Upcom, like the HNX, went up slightly by 0,51 pts (+ 0,62%) and closed at 83,07.

VN30 also corrected and decreased -5,96 pts (-0,47%), closed at 1251,81. The stocks that caused VN30 covered in red were MBB (-1,9%), VCB (-1,9%), VIC (-1,8%) ... There were very few gainers in this group and represented by KDH (+ 1,8%), HDB (+ 1,1%), NVL (+ 0,8%) ...

Although Hose dropped, there were tickers that went in the opposite direction such as CKG (+ 6,9%), SAV (+ 6,9%), DIG (+ 5,5%) ... HNX gained, resulted in many stocks had good signals such as TDN (+ 9,6%), HHG (+ 9,5%), VE1 (+ 9,7%) ... On Upcom, strong gainers were CEN (+ 14,9%), SCL (+ 14,5%), SJG (+ 14,5%) ...

Foreign investors slightly net bought VND +20bn, but lightly sold VND -12,85 bn on HOSE including BID (-37,6 bn), VNM (-30,2 bn), and KDH (-30,1 bn) ... And on HNX, they net bought VND +28,16 bn, strongly focused on VND (+19,4 bn), SHS (+10,2 bn), IDV (+1,0 bn) ... Upcom also had low net buy value of VND +4,72 bn and at QNS (+8,3 bn), SIP (+3,2 bn), HPP (+2,5 bn) ...

After gaining streaks, this is the first correction session of market. Although market declined, stocks were strongly polarized, showing that money flow is still in the market and always looking for good investment opportunities. Therefore, investors can take advantage of the correction phase for short-term trading or wait for good stocks to adjust appropriately to increase their proportion.

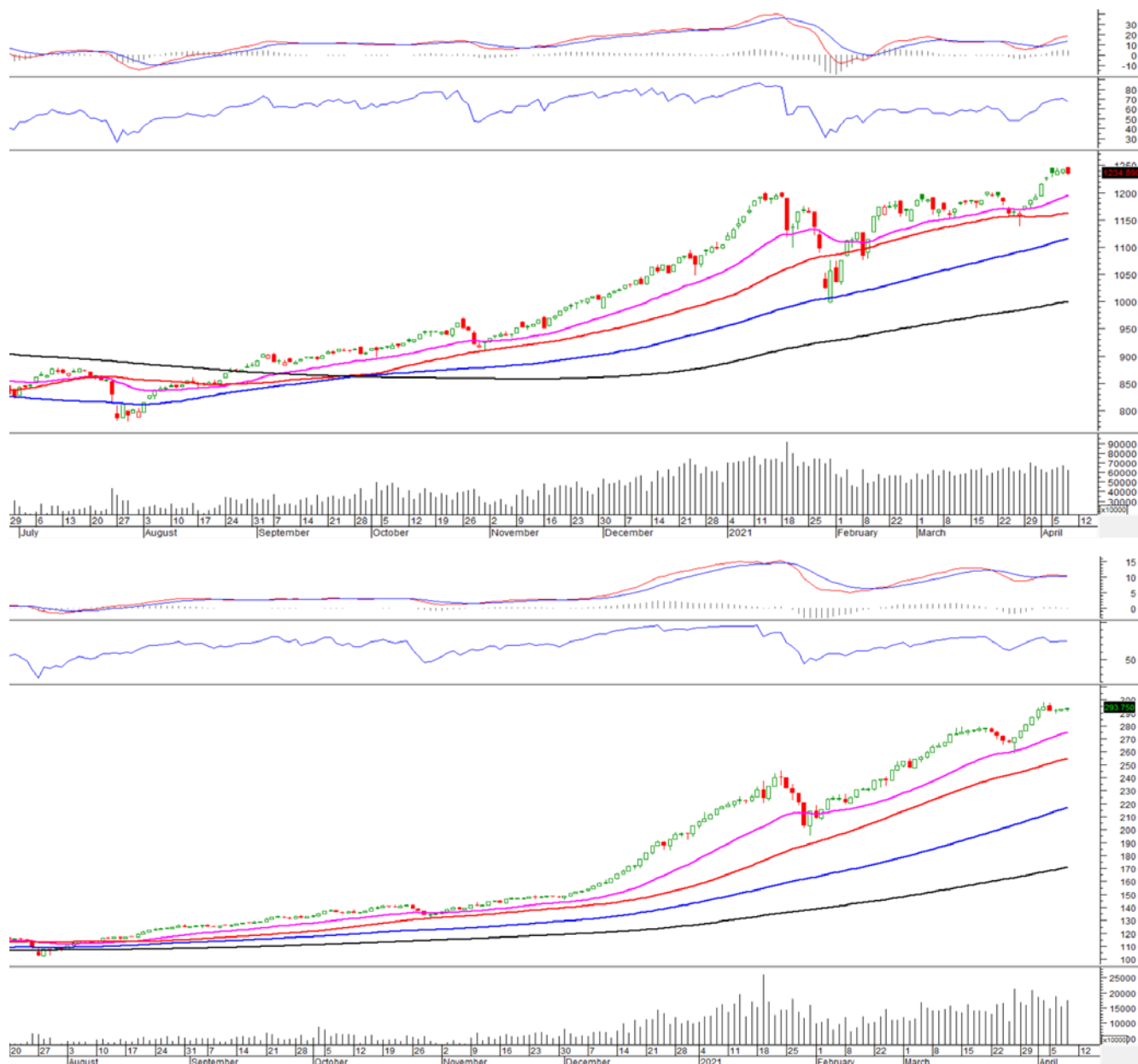
