“Recorded a new height”

Market today: Recorded a new height

Despite cautious movements in previous session, VN-Index surpass the resistance zone of 1190-1200 points and recorded a new high. At the end, VN-Index increased by 24.66 points (+ 2.07%) and closed at 1216.1 points. HNX-Index increased by 5.73 points (+ 2%) and closed at 292.4 points. Liquidity decreased, with 637.1 mn shares traded on HOSE. The most notable was Securities stocks, with many tickers outperformed.

VN30-Index outperformed and also recorded a new height, with an increase of 2.5%. There were 29 gainers, outstanding stock was SSI which increased to the ceiling, followed by TCH (+ 5.9%), VIC (+ 4.3%), MBB (+ 3.7%), HPG. (+ 3.6%) ... Only 1 stock in red was MSN with a slight drop of 0.2%.

Small and medium stocks continued to follow market's uptrend but a little hesitated with many stocks cooled down. Notably, some tickers increased to the ceiling such as HAR (+ 7%), HHS (+ 6.9%), DAH (+ 6.9%), RIC (+ 6.8%), AAT (+6, 8%).

Foreign investors turned to be net buyers on HOSE with a value of VND 45.3 bn. The most prominent was VIC with a net buy value of VND 271.1 bn, followed by HPG (+92.4 bn), STB (+67.3 bn), MSN (+54.8 bn), NVL (+45,7 bn) ... On the net sell side, noticeable was VNM (-186.8 bn), followed by CTG (-179.2 bn), GAS (-72 bn), VCB (-43.2 bn), VRE (-12.7 bn) ..

Market's sentiment was released after VN-Index surpassed the resistance zone of 1200 points and recorded a new height. Liquidity decreased compared to the last 2 sessions but also recorded the index's effort. It is likely that market will fluctuate due to fast gaining movements but it will be supported and in a positive direction in the short term. Therefore, investors can hold portfolio until market shows a specific resistance signal, or can participate in short-term buying at some stocks with good technical signals after an accumulation period.

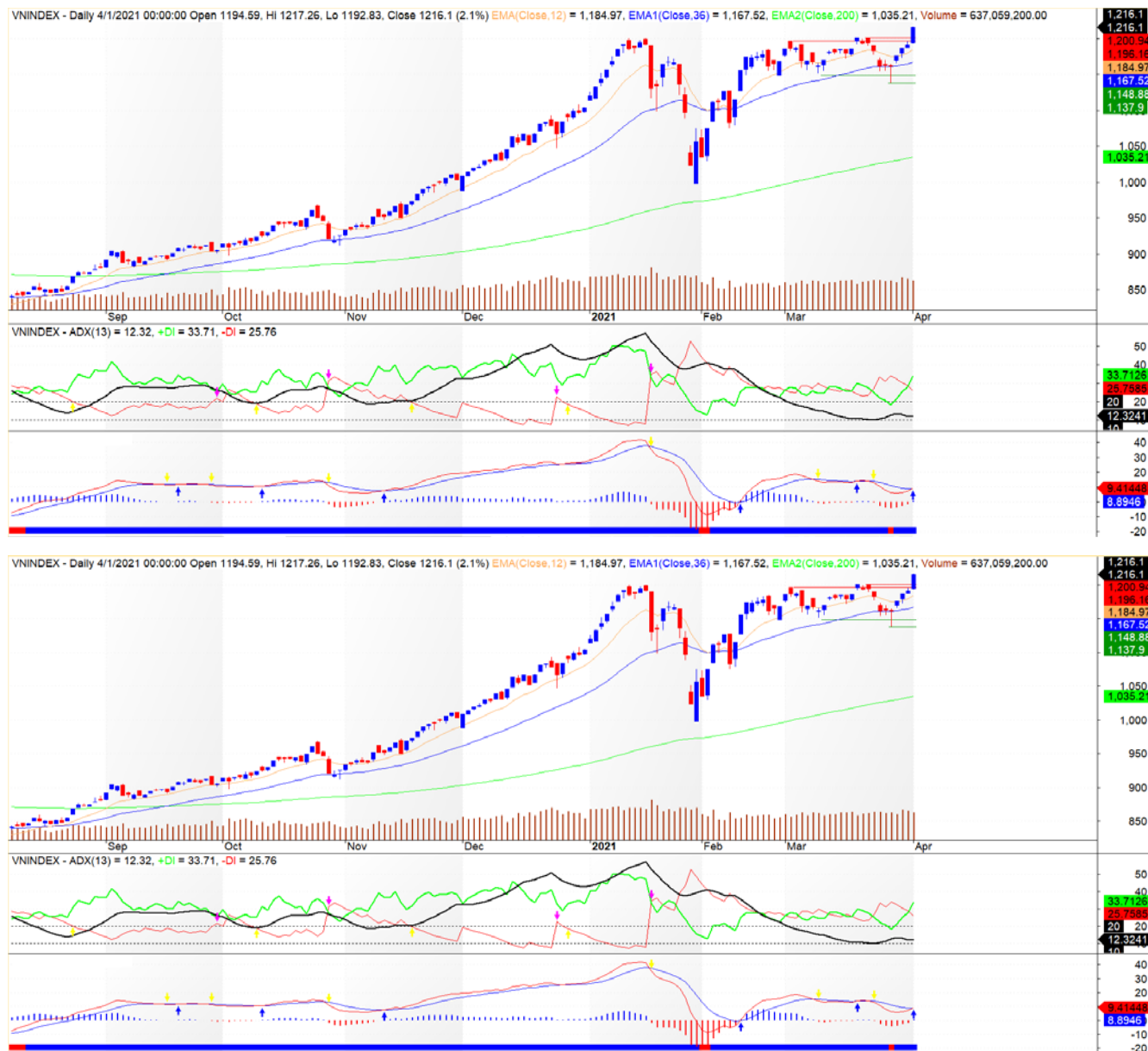
HSG update – Strong performance in 2Q and 3Q FY2020-2021
