"Missing 1100 points"

Market today: Missing 1100 points

Market onopened in a positive state and VN-Index surpassed the resistance zone of 1100 points. However, market could not keep its momentum in the afternoon as profit taking action increased. At the end of session, VN-Index fell below 1100 points, decreased 1.95 points (-0.18%) and closed at 1097.54 points. HNX-Index dropped 0.16 points (-0.08%) and closed at 196.94 points. Trading liquidity decreased slightly from previous session, with 619.8 mn shares matched on HOSE.

VN30-Index also suffered from regressive pressure in the afternoon but closed in green and increased 0.07%. There were 15 gainers and 15 losers. EIB saw an unexpected movement, gained to the ceiling at the end of ATC session, followed by ROS (+ 2.9%), PNJ (+ 2.4%), VIC (+ 1.9%), and REE (+1.3). On the losing side, there were 3 losers over 1% such as HPG (-1.7%), NVL (-1.6%) and VCB (-1.3%), the rest dropped slightly below 1%.

Small and medium stocks also slowed down. However, there were still lots of positive gainers that gained to the ceiling, notable were DGW (+ 7%), BWE (+ 7%), EVG (+ 7%), HTN (+ 6.9%), NHH (+6.9 %) ... The number of losers tended to increase compared to previous session and there were lots of strong losers such as CRC (-7%), ASM (-5.5%), BCG (-4.3%), IDI (-4.2%), LCG (-4.2%) ...

Foreign investors continued to be net sellers on HOSE, with value of VND 281.6 bn. Notable was HPG (-223.2 billion), followed by MBB (-50.5), VNM (-44.9), KBC (-35.7), VHC (-32.8) ... On the net buying side, notable was FUEVFNVD (+35.3), followed by VCI (+30.1), VRE (+18.5), VHM (+14.6), VCB (+12.4) ...

Despite surpassing the resistance zone of 1100 points during the session, at the end of session VN-Index still temporarily failed to surpass this area. It shows that 1100 points area is still difficult for market. Although there was a weakening movement at the end of session, it was only lightly and temporarily not enough to show that market has ended its current uptrend. However, it should be noted that profit taking will continue and tend to increase in the near future, especially when VN-Index records new heights. Therefore, investors should observe trading dynamics to reassess market status, at the same time manage portfolio risks closely and continue to take profits for stocks with great selling pressure at the barrier to avoid unexpected risks.

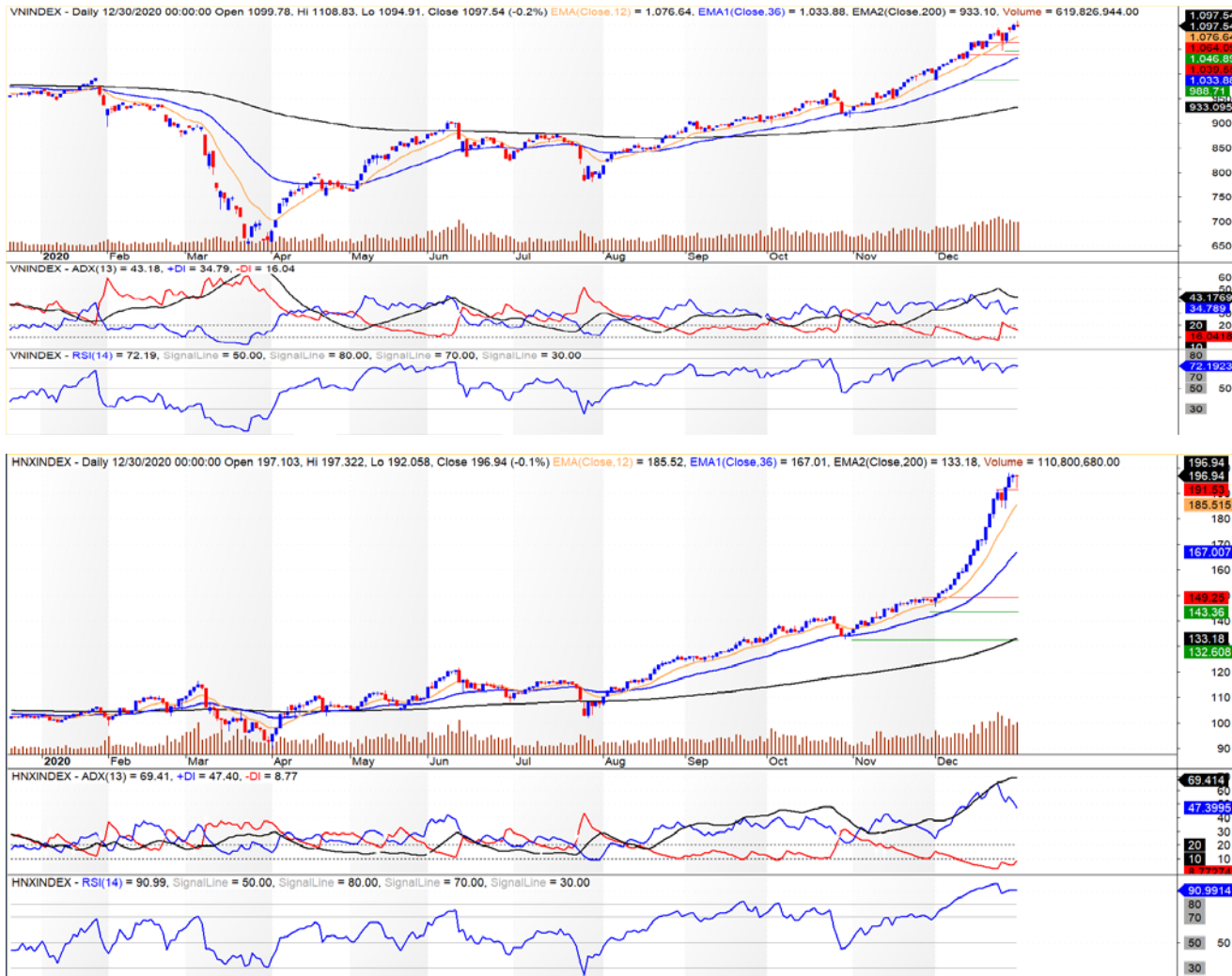
PC1: Wind power market enhances the performance in 2021
