Market today: Setback

Today's market opened positively with the green still outperforming, pushing the major indexes continuously to hit higher zones. However, selling pressure suddenly rocketed in the afternoon session, dragging the morning's attempt to gain. VN-Index decreased slightly by -1.44 points (-0.1%) and closed at 1,502.34. Liquidity also plummeted compared to the previous session, with 788.7 million shares matched on HOSE.

The selling pressure was more obvious in the VN30 basket as the index closed worse than the VN-Index with a plunge of -7.81 points (-0.52%). The number of losers dominated among the group when there were 22 draggers and 7 gainers. Groups with the deepest drop included GAS (-2.3%), PNJ (-1.8%), PLX (-1.4%), HDB (-1.1%), PDR (-1.1%)... On the contrary, POW led the gaining group with an increase of +2.4%, followed by SAB (+2.3%), GVR (+2.2%), BVH (+0.9%), KDH (+0.4%)...

Regarding the movement of industry groups, except for Chemicals and Fisheries, the rest cooled down quickly in this afternoon session. Real estate and Oil & Gas were also the focus of selling yesterday, continuing to decline. Besides, Utilities, although suddenly soared in the morning, had to step back due to the pressure of profit-taking.

Foreign investors continued to be net buyers for the third consecutive session on HOSE, with VND 1,020 billion. The most robust net buying was still DGC (+310 billion), MSN (+152.5 billion), FUEVFNVD (+103.4 billion), STB (+86.6 billion), KBC (+79.1 billion)... On the other side, they net sold VNM (-89.2 billion), DCM (-70.9 billion), VCI (-58.8 billion), NVL (-54.2 billion), VND (-35.3 billion)...

The market's uptrend remained to slow down at the resistance zone of 1,510-1,515 points. However, there was a vigorous session of buying in the afternoon, reflected in the higher liquidity in the morning. Moreover, the liquidity also surged gently at the last minutes, showing a slight bottom-fishing signal. However, we believe that, with more obvious profit-taking pressure, the market will likely step back to find a balance point. Therefore, investors should observe and re-evaluate the market during the correction. However, it is still possible to consider participating in some stocks attracting cash flow on a positive accumulation background.
