Market today: Surprise at the end

Opening with an exciting gain but market could not sustain its momentum till the end as selling pressure increased in the afternoon. End of session, HOSE slightly decreased -0.09 points (-0.01%) and closed at 951.9. HNX followed HOSE with a drop of -0.24 points (-0.17%) to close at 141.37. Only Upcom was not affected as it still gained +0.14 points (+ 0.22%) and closed at 64.16.

Being exhausted at the end with overwhelming selling orders, VN30 slightly decreased -0.92 points (-0.10%), closed at 916.50. Losers were KDH (-1.6%), PNJ (-1.4%), VNM (-1.2%), CTG (-1.1%) ... However, there were gainers such as VJC (+ 7.0%), VRE (+ 2.3%), GAS (+ 1.1%), SSI (+ 1.1%)...

Besides, there were stocks not affected by selling pressure on HOSE such as AST (+ 6.9%), VND (+ 6.9%), TVB (+ 6.8%), HVN (+ 5.8%)... On HNX, outperformed stocks were KSD (+ 7.9%), BNA (+ 5.1%), PVS (+ 4.4%). Gainers on Upcom were ABC (+ 8.8%), VTR (+ 5.3%), KDF (+ 5.1%)

Foreign investors returned to net sell with total value of VND -745 bn. HOSE was still a focus with value of VND 764.08 bn, strongly focused on HPG (-187.2), MSN (-132.7), VNM (-122), CTG (-106.3)... there was net buy with a small value on HNX of +14.09 bn, focused on KSD (+11.5), PVS (+7.3) ... Value on Upcom reached +4.32 bn, mainly on MCH (+4.9), VEA (+3.8), VRG (+1.2)

Market boomed but selling pressure at the end caused anxiety for short term investors. However, this is a shaking movement in short – term and market trend has not yet shown any negative signals. Therefore, investors can establish their sentiment or wait for the confirm of market's movement.
