Market today: Pennies rise

VN-Index fluctuated in narrow range for two consecutive sessions. VN-Index closed at 976.48 (+0.79 points or 0.08%). While HNX-Index continued to decline, closing at 105.79 (-0.3 points). Liquidity was still stable at a low average level. Even though Vn-Index ended higher, number of decliners outweighed that of gainers.

VN-Index managed to slightly increased due to: ROS (+ 6.6%), SAB (+ 4.9%), GMD (+ 3.8%). Notably, ROS and SAB were two biggest decliners in the previous session. Most of the remaining stocks in the VN30 Index basket declined slightly.

Penny and Midcap stocks rose with many gainers such as SRC (+ 6.9%), SFG (+ 6.6%), D2D (+ 5.2%), NAF (+ 4.5%), NDN (+4.9 %), AMV (+ 4.8%), HDC (+ 4.1%), LSS (+ 4%), LHG (+ 3.1%), BMI (+5.5), NBB (+ 3.9%), CMG (+ 3.1%). Obviously, many Real estate stocks were still attracted to investors.

Foreign investors ended their 8-day net selling streak on HOSE with a net bought of VND 10 bn. However, they still net sold VND 15.6 bn on HNX. Transaction mainly focused on VinGroup stocks. VRE (+VND 39 bn) was the top net buying stock, while VHM (-18 billion) and VIC (-15 billion) were the two top selling stocks.

The market slowed down after 5 consecutive gaining sessions of VN-Index. Large cap stocks fluctuated, while Mid and Penny stocks rose strongly. A slight correction is taking place, but market, generally, is still positive. Many stocks have an opportunity to buy.

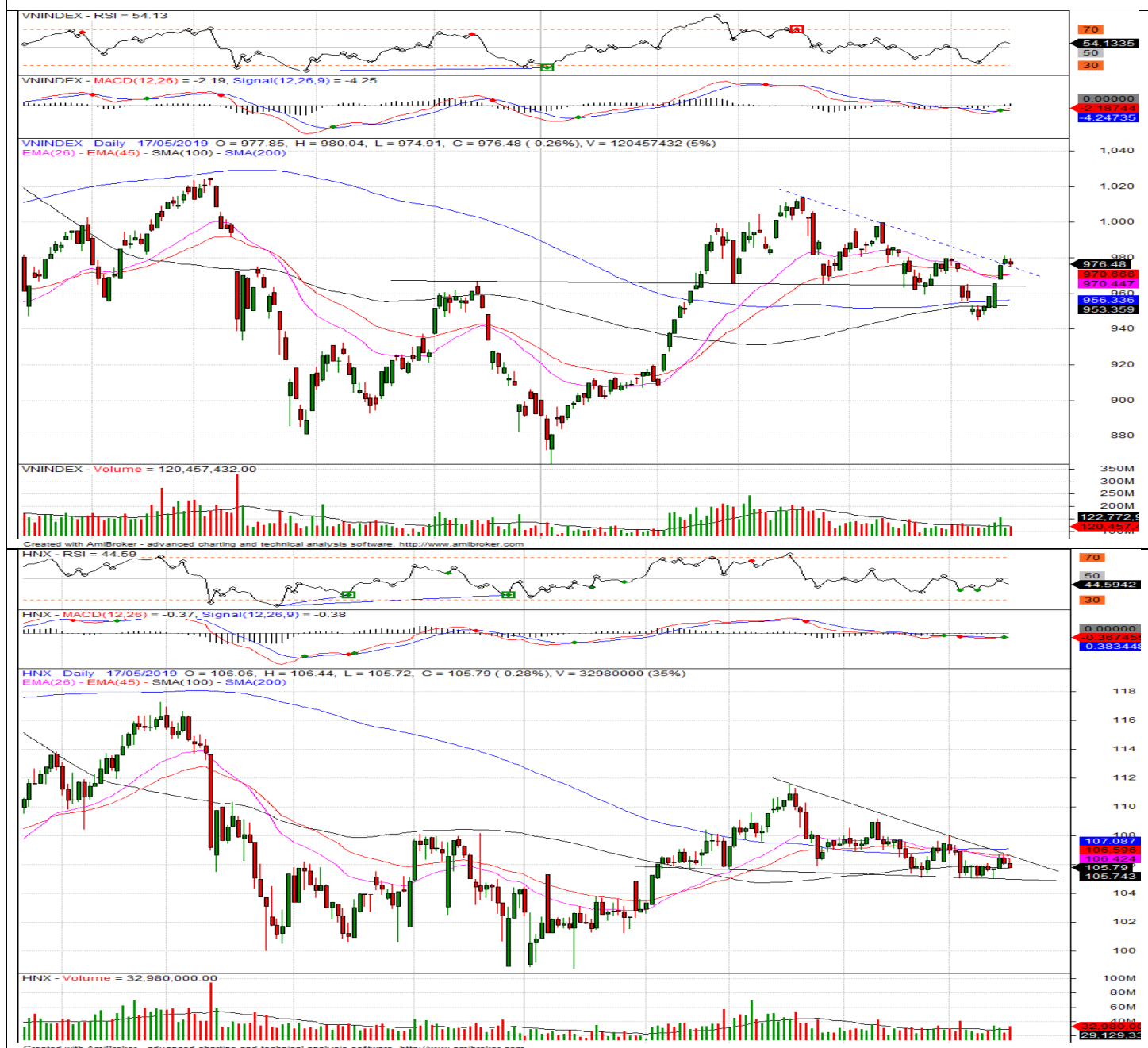

Technical Analyst Recommendations

VN-Index almost unchanged while HNX-Index reduced slightly. The liquidity remained quite steady on both exchanges. After 5 consecutive gaining sessions, VN-Index tends to slow down and retreat slightly. This may be just a short-term retracement. Trading should disburse on correction, focus on oversold stocks.
