Market today: Slight Gain on the Back of ETFs Structuring Portfolios

Today was the last day in Q2 that ETFs structured their portfolios. As usual, we saw a dull and sleepy atmosphere in the morning when investors seemed to stand aside until the ETFs finished their trading. For the rest of today's session, the market looked better and closed in the green, but liquidity was still very low. Capital movements at this time seemed quite quiet.

The VN30 gained 0.1%, while the VNMID and the VNSML declined by 0.2% and 0.1%, respectively.

Many large caps, including ROS, VIC, VJC and BVH, fell deeply. Top outperformers were GAS, SAB, CTD, and some banking stocks (ACB, VCB, CTG, BID).

Foreign investors net sold VND 542 bn on the HSX and VND 42 bn on the HNX. Overall, in the week that ETFs structured their portfolios, we saw 4 strong net selling sessions.

The market sentiment looked quite weak and the downtrend could remain intact. Large caps are under strong selling pressure. Although a window of opportunities seemed to appear among mid and small caps, we believe investors should keep cash and stocks in balance and wait for more obvious signals.
