Market today: Fear disappeared

Unlike the previous session, Vietnamese stock market regained its balance and strongly recovered. On HOSE, Vnindex increased +18.11 points (+ 1.9%) to close at 968.9. HNX followed with an increase of +3.22 points (+ 2.25%), closed at 146.58. Upcom continued its rise of +1.3 points (+ 2.0%), closed at high of the day at 66.15.

There were no losers on VN30. This had a positive impact on the index, when ended with gain of +18.68 (+ 2.04%), closing at 934.65. Outperformed gainers on VN30 were GAS (+ 4.1%), VIC (+ 3.9%), TCH (+ 3.6%), VPB (+ 3.5%) ... Only ROS closed at reference price.

In addition, on HOSE, Midcap and Penny increased strongly during the session such as ASM (+ 7.0%), HVH (+ 7.0%), ACC (+ 6.9%), CTS (+ 6.9%)... Beside leading stocks such as ACB (+ 3.8%), HNX owned strong gainers like MST (+ 9.3%), VGS (+ 9.2%), HLD (+ 7.7%), SLS (+ 7.2%)... on Upcom, gainers were SEA (+ 14.9%), TVN (+ 14.1%), PVG (+ 11.2%), SIP (+ 9.6%) ...

Foreign investors remained net sell with the total value of VND -112 bn. HOSE was still the spotlight as its net sell value was VND -117.38 bn, mainly focused on HDB (-144.2), PVD (-39), VPB (-27.4), SAB (-25.4)... HNX saw a minor sell value of VND -6.65 bn, strongly focused on TNG (-7.3), VCG (-3.9), SLS (-1.9) ... Luckily, Upcom saw a net buy of VND +11.72 bn, focusing on ACV (+11.5), MCH (+9.0), and VTP (+5.8) ...

Although stock market has gained sharply, it has not been able to breakthrough strong resistance area of 970. We see that market still accumulate in this area and prepare to breakthrough and move to higher level. Investors can take advantage of that to trade short term at stocks with positive trend.
