Market today: Trading Activity Remains Unexciting

(Quang Vo – Ext: 1517)

Trading activity did not show any improvement signals. SAB declined deeply for the third consecutive session, partially explaining the 7.45-point loss of the VNIndex (946.06 points, -0.78%). In fact, selling pressure occurred in a wide scale as all the VN30, the VNMID, and the VNSML stocks saw negative market breadth.

Banking and oil & gas, the two industries that led yesterday’s session, showed disappointed performance today. Only GAS in the oil and gas industry notably supported the VNIndex’s gain, while just MBB and VPP ended successfully above their reference prices in the banking space. This makes VRE’s and VNM’s effort become meaningless.

On the other side, we saw fertilizer stocks turning positive. DCM proved to be the strongest one as it went to the ceiling. VAT is still the most relevant factor that drives these shares. Recall that investors are expecting exported products processed from gas to be applied with 0% VAT. However, even if this happens, we think the contribution to DCM is still minor because the exported fertilizers account for only around 10% of its total revenue. Also, the rumor of PVN divestment is affecting this industry.

Some expert swing traders might benefit from the current market volatility. For example, once can quickly take long stocks that have strong fundamental elements as they are oversold during ATC session like today, and then gain profit after a couple of days.
