With the prudent money flow in the previous session, the market witnessed a gloomy new session. Conservative movements swallowed the trading time, and sometimes VN-Index retreated quite profoundly. However, with the efforts of large-cap stocks in the VN30 group, the market recovered positively in the ending session. VN-Index gained 2.87 points (+0.19%) and closed at 1,522.9 points. Liquidity rallied compared to the previous session, with 912.7 million shares matched on HOSE.

The VN30 group outperformed the general market, with a soaring of 1.16%. In the group, there were 20 advancers and 9 decliners. There were many strong supporters for the index such as VPB (+4.3%), FPT (+3.7%), HPG (+2.5%), MWG (+2.3%), BVH (+2.2%) ... However, VIC (-2.2%), KDH (-1.9%), NVL (-1.6%), VNM (-1.4%), GAS (-0.5%) were some weighty decliners.

Although the market reversed to retrieve, the number of losers still dominated the market. Cash flow is moving towards large-cap stocks. Technology, Steel, and Banking are the main drivers of the market. Concurrently, Retail and Beverage also contributed support. While, Real Estate, Construction, Electrical Equipment and Logistics had a poor performance.

Foreign investors turned out to be net buyers of HOSE, with a value of VND 109.2 billion. The notable names were DXG (+73 billion), STB (+72.1 billion), SSI (+65.7 billion), MSN (+52.6 billion), NVL (+49.4 billion) ... The net selling side had HCM (-53 billion), GAS (-40.7 billion), NLG (-34.8 billion), GEX (-30 billion), VIC (-27.1 billion) ...

The market performed poorly during the session but reversed at the last minutes after finding the balance zone. Liquidity increased compared to the previous session, showing that cash flow is actively participating again, especially in VN-Diamond and VN30. With the large-cap bolster, the market will remain on its upward journey shortly and retest the old peak area, the area of 1,535 points for VN-Index and the area of 1,585 points for VN30-Index. Therefore, investors can expect the market's uptrend, prioritizing stocks with a reasonable valuation, positive accumulation background and attracting cash flow. However, they still should be careful with risky high stocks.

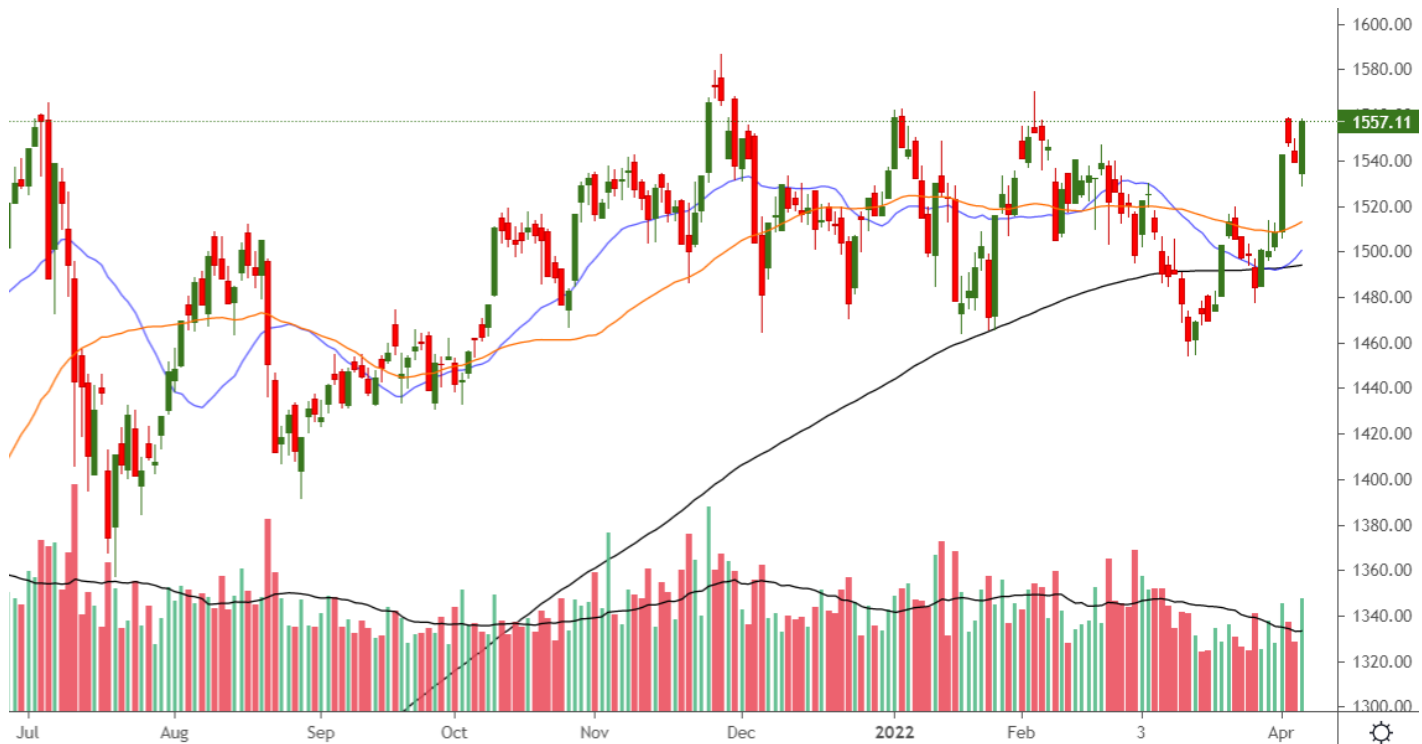
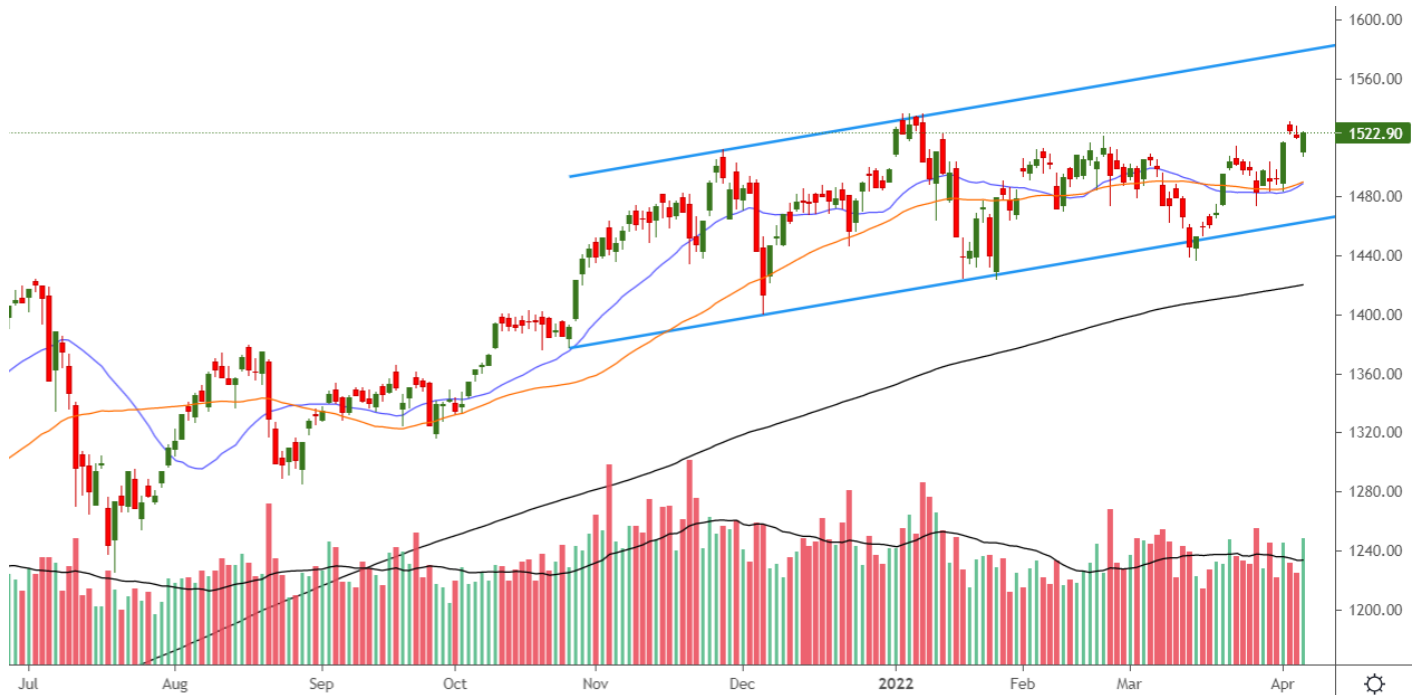
