Market today: The Index Returned to its Starting Point

(Hieu Nguyen - Ext: 1514)

VN30 stocks declined modestly, most notably VNM, which pulled the index in the red for the whole session. The recovery of ROS from the floor price helped to cover a significant portion of the decline. Thus, at the end of the session, the VN-Index fell by only 0.34% to 675.87 points. ACB had a notable block trade today, with 17.7 million shares trading at the ceiling price, equivalent to a value of VND378 billion. By the end of today's trading, the VN Index closed near its initial level during the beginning of this week.

SCIC has updated a legal document for its divestment of VNM. The auction will be delayed 10 days from the previous announcement date, and will be on 12/12/2016. Out of the total VND800 billion net selling value, foreigners net sold VND583 billion worth of VNM's shares. Strong selling pressure forced VNM to retreat to VND134,500/share, which is a 2-month low.

The VN-Index had some chances to surpass 680 pts thanks to separate support of some large cap stocks. The rallies were just temporary recoveries and did not last long, and we did not see significant changes in capital inflow. The daily average trading value was VND2,000 billion in the HSX and VND300 billion in the HNX. Lack of information and concerns of the VND's depreciation were the 2 main factors that negatively impacted short term trading. **On average, only 18% of the total shares on both bourses gained 4% or higher.** The current trend may not alter much in the future.
