Market today: Banking group motivation

- After a struggle at the 1,170 level, the market resumed its uptrend and crossed the 1,180 level.
- With the current momentum, it is likely that the market will overcome the resistance zone of 1,185-1,190 after a struggle.

The market rallied as soon as the new trading week began. Although there were fluctuations in the morning session, the market extended its rise in the afternoon session with the gradual increase in the status of the banking group. VN index increased by 13.51 points (+1.15%) and closed at 1,186.06 points. Matching liquidity decreased slightly with 770 million shares matched on HOSE.

VN30 group rose 22.6 points (+1.92%) to close at 1,197.36 points. Up to 21 gainers such as CTG (+6.9%), ACB (+5.9%), MBB (+5.5%), VIB (+4.7%), TCB (+4%) ... On the contrary, there are only 6 losers like VRE (-2.2%), BCM (-1.6%), MSN (-0.8%), POW (-0.4%), VCB (-0.3%), PLX (-0.1%).

Despite the market's strong rally, the number of advancing stocks is not much higher than the number of declining ones, showing the market's polarized state. Banking group was back as the main driver of the market's upward movement. Besides, the Transportation - Warehousing group, Securities group, Food group... showed a slight improvement.

Foreign investors returned to net buying on HOSE with a value of VND 55.4 billion. In particular, CTG (+195.9 billion), STB (+93 billion), FRT (+51.9 billion), HAH (+42.2 billion), VND (+37.4 billion) were the top buying ones... On the other hand, they sold heavily at TPB (-102.5 billion), VCB (-55.3 billion), SSI (-53.2 billion), VRE (-49.5 billion), GEX (-42.1 billion)...

After a struggle at the 1,170 level, the market resumed its uptrend and crossed the 1,180 level. Liquidity decreased from the previous session, but was still quite good, indicating that cash flow is trying to support the market's value. Currently, the market is challenging the resistance zone of 1,185-1,190. With the current momentum, it is likely that the market will overcome this resistance zone after a period of struggle. Therefore, investors can expect the market to extend its upward trend. At the moment, investors should give priority to stocks that show good signals from the support zone to hold or buy cumulatively, but they should still consider taking short-term profits on stocks that are rising rapidly to the resistance zone.

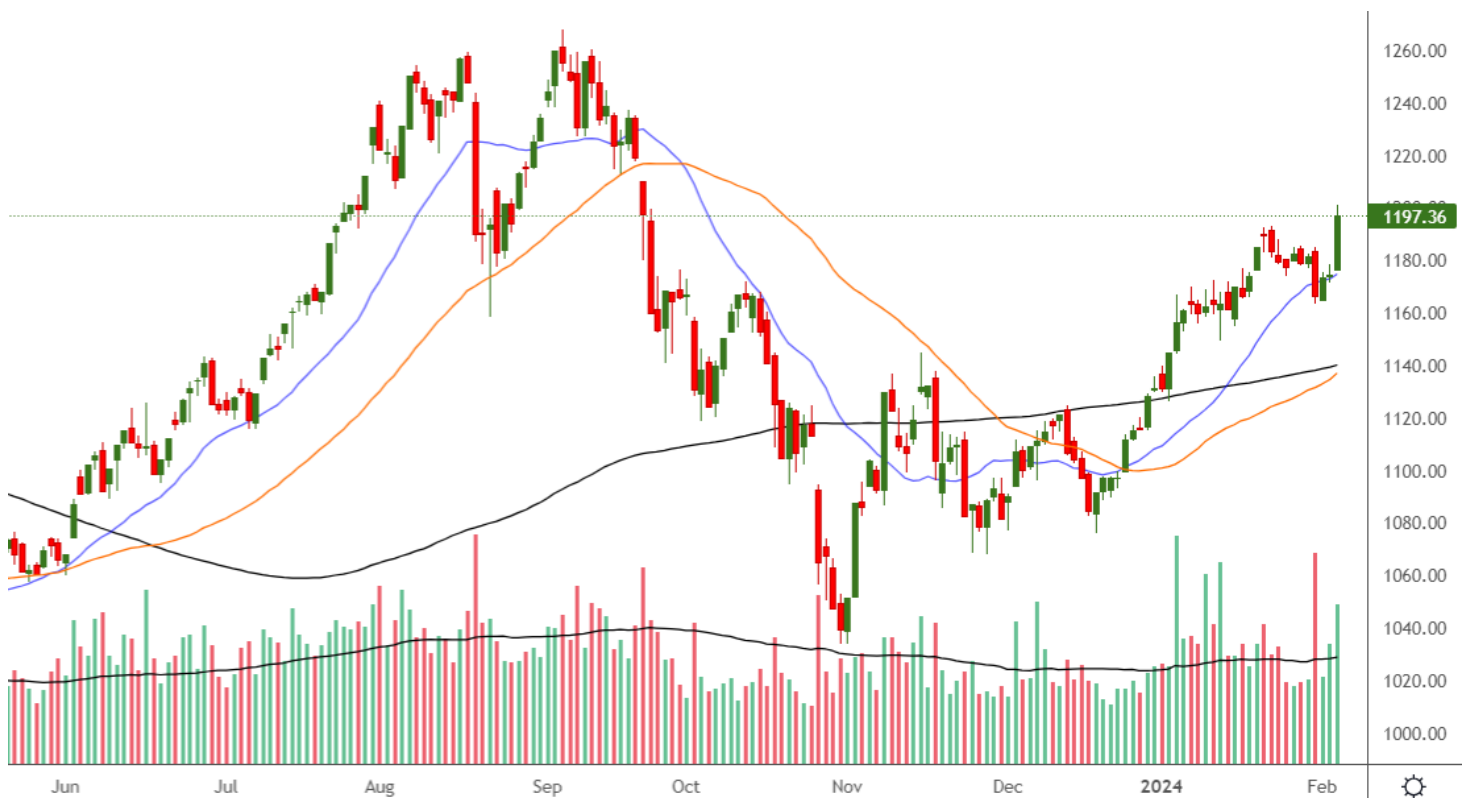
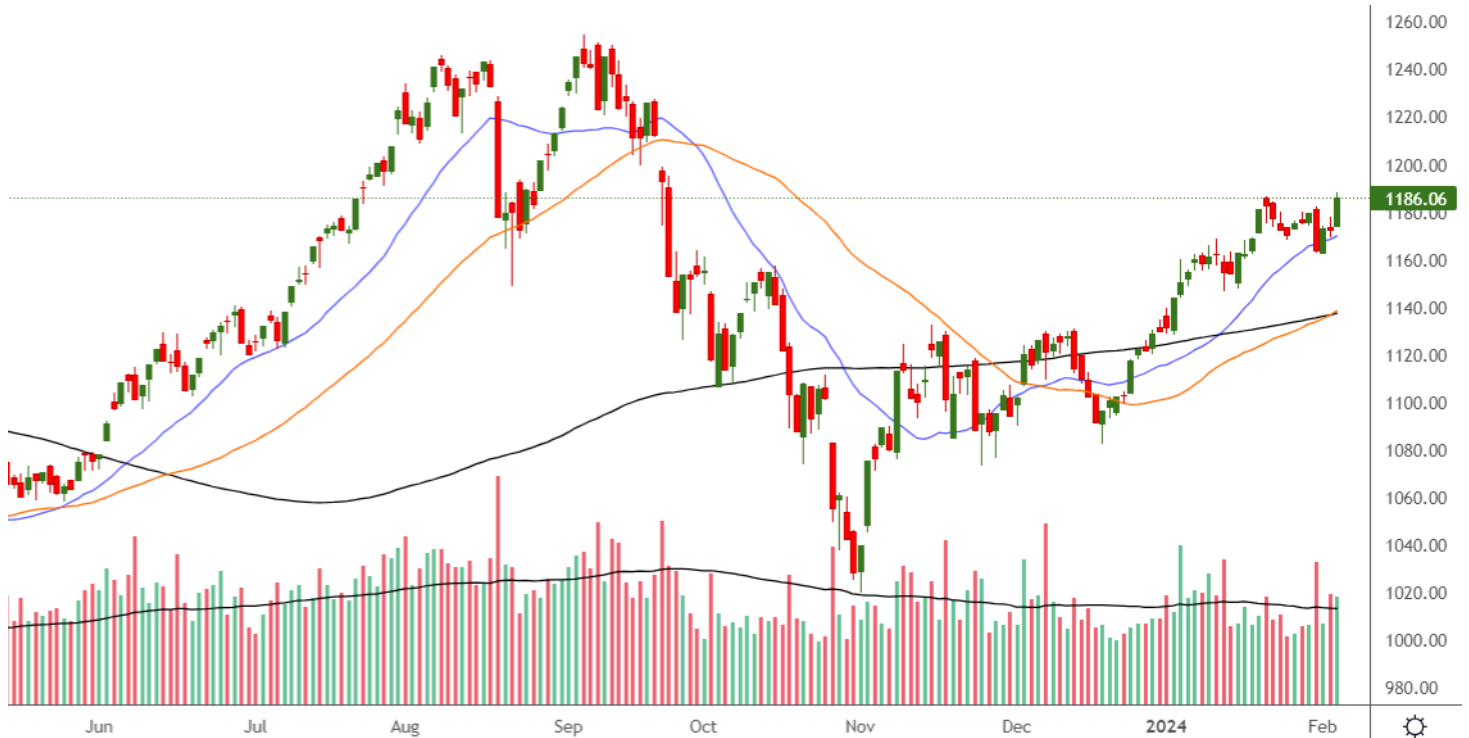
